The County has a negative balance with federal aid, so it will be a few years before there will be federal aid available to Dickey County. Peterson reminded the Commission that there will be "Prairie Dog" funds from the state of North Dakota each biennium that should start in 2021, which could be used for these projects. The form will be updated by the state and will be returned to be signed later in the year.

Hagen discussed with Commission concerning a meeting on October 8<sup>th</sup> with DOT concerning the letter received earlier concerning bridges on the Garrison Diversion project in the Oakes area. The Commission feel that the project was not completed so the bridges should not be the property of the county. Peterson has agreed to attend the meeting as well. Hagen and Peterson will go look at the bridges so that Peterson has a better understanding of the bridges.

Hagen informed the Commission of the propane bid opening October 1<sup>st</sup>. Hagen stated he had informed Elm Township that the County will no longer be maintaining the roads out at Pheasant Lake. The County will continue to the end of year. The roads will be graveled before the end of the year.

Hagen presented two utility permits from Wanzek to put a water line in along 72<sup>nd</sup> Avenue and also along 93<sup>rd</sup> Street. Hagen stated he had no concerns. Hagen also had a utility permit from Dakota Valley Electric to bore power under County Road 5 east of the intersection of County Road 6 and 100<sup>th</sup> Avenue SE.
