Commissioner Meeting via Zoom

Commissioner Marke Roberts called the meeting to order at 9:10. Present were Thor Sand, John Hokana, Joel Hamar, Dean Simek, and Chairman Marke Roberts. The media was not present. The Pledge of Allegiance was recited. Employees Don Flaherty and Danielle Dinger were also present.

Hamar made a motion to approve the minutes from April 17th, 21st, 24th, and 29th with corrections. Sand seconded. Roll call vote with Sand yes, Hokana yes, Hamar yes, Simek yes, Roberts yes. Motion carried.

Hokana made a motion to approve the vouchers. Hamar seconded. Roll call vote with Sand yes, Hokana yes, Hamar yes, Simek yes, Roberts yes. Motion carried

MDU poles in the right of way

Sheriff Chris Estes joined the meeting at 9:30.

Hamar reported to the Commission with an update on the basement project at the Courthouse. Architect Kerry Peuser and Hamar had discussed the current contractor environment and the current financial environment. The question was asked if there was asbestos in the Courthouse and if the cost of removal of the asbestos is included in the estimate of the project. Sheppard informed the Commission on the concerns voiced by employees of the dust, mold, and asbestos, if the offices were to remain open at the Courthouse during the tear out of the basement floor. Commission requested Estes to look into options for relocating of the Sheriff's office during construction. Peuser had stated the project could take approximately six to eight months to complete.

Clerk of Court Andi Schimke joined the meeting at 9:45.

Estes updated the Commission on the hiring of a new administrative assistant for the Sheriff's office. Estes has offered the position to Colleen Rithmiller, who held the position several years ago. Estes feels that her past knowledge of the positions will be extremely helpful. Simek made a motion to hire Rithmiller at Step 7 on the salary scale on the Office Deputy line. Sand seconded. Roll call vote with Sand yes, Hokana yes, Hamar yes, Simek yes, Roberts yes. Motion carried. Rithmiller will be starting May 11th to allow for training time with the current administrative assistant, Andrea Masse.

KLJ Engineer Bryan Tykwinski joined the meeting at 10:12.

Flaherty presented the adjusted County Equalization meeting notice for June 4th to be posted in the Dickey County Leader. A change was made so that the Township meetings followed directly after the Cities. Flaherty stated that he believes there may be one protest on a commercial value.

The Committee set to interview candidates for the construction engineering for the road safety projects on Dickey County #8 and #14 reported their findings to the Commission. Sand, representing the Committee who also include Simek and Highway Superintendent Jeff Hagen, informed the Commission interviews had been completed and that the Committee felt that both firms were capable of completing the project, but felt that KLJ had a slight advantage and would recommend that the Commission appoint KLJ as the Engineering firm for the project. On recommendation of committee, Hokana made a motion to approve the hiring of KLJ for the project. Hamar seconded. Roll call vote with Sand yes, Hokana yes, Hamar yes, Simek yes, Roberts yes. Motion carried.

The Dickey Sargent Joint Water Board has requested that the funds for the joint Jackson Township drain project be transferred to Sargent County. The secretary for the Joint Water Board works out of Sargent County and the board felt it would be better served by having the funds in Sargent County. Simek made a motion to move the funds from the Joint Jackson Township Drain project to Sargent County. Hamar seconded. Hokana requested that the Commission get a report on the funds expended on that fund on a monthly basis. Roll call vote with Sand yes, Hokana yes, Hamar yes, Simek yes, Roberts yes. Motion carried.

Discussion followed concerning the electric poles that are still in the right of way.

Roberts updated the Commission on a request he had received from Oakes Mayor Zimmer concerning the zoning committee for the city of Oakes. State law states that the committee has to include someone that lives outside the city limits. Zimmer has requested that the Commission appoint April Haring to that Committee. Hokana made a motion to appoint April Haring to the Zoning Committee for the city of Oakes, based on their recommendation. Simek seconded. Roll call vote with Sand yes, Hokana yes, Hamar yes, Simek yes, Roberts yes. Motion carried.

Highway Superintendent Jeff Hagen and DES/911 Coordinator Charlie Russell joined the meeting at 10:45.

Hokana updated the Commission on the request to lift road restrictions to haul potatoes out on County Road 5 starting Sunday. Commission felt they needed more information concerning the request and would like a special meeting Wednesday to get the additional information needed to make a decision. The Covid meeting will be moved from Friday to Wednesday.

Tykwinski gave an update to bridges with alert codes on them, from the State of North Dakota. The bridge on County Road 8 will be monitored. The other bridge, which is located off of 80th Street approximately a half mile on 86th Avenue. The bridge is old and has the wood pilings and abutments. A decision will need to be made on what should be done with that bridge. That decision will need to be made by July 15th.

Sheppard informed the Commission that a letter has been sent by the State Highway Patrol, asking if the County would like assistance with patrolling the county roads for load limits. Hamar made a motion to request assistance of the Highway Patrol. Simek seconded. Roll call vote with Sand yes, Hokana yes, Hamar yes, Simek yes, Roberts yes. Motion carried.

Hokana made a motion to adjourn at 12:01.

Special Commissioner Meeting via Zoom May 6, 2020

Chairman Marke Roberts called the meeting to order at 1:36. Present were Dean Simek, Joel Hamar, John Hokana, Thor Sand, and Chairman Marke Roberts. Also present were employees Jeff Hagen, Chris Estes, Kim Radermacher, Danielle Dinger, Roxanne Holm, Don Flaherty, Deb Anderson, Wonada Lematta, Andi Schimke, Cresta Miller, Amber Miller, Charlie Russell. Also present were residents Scott German and Steve Kasowski.

Kasowski updated the Commission on his schedule for hauling his perishable crop, potatoes, to the warehouse in Grand Forks. The timing of getting potatoes off the pile and getting them to Grand Forks is crucial. Kasowski stated that at this time, it was crucial for him to get enough loads out to get to a potential bad spot in the pile at his warehouse. Trucks normally loaded to approximately 90,000 pounds. Kasowski stated that he will continue to maintain the road to keep the road passable for all traffic. If the rain returns and the road becomes impassable, Kasowski stated he will pull the trucks.

Discussion followed concerning the issues this could cause with other producers. Russell stated the roads across the county are not in good shape, with the rain from the weekend. This issue could be county wide, not just this one stretch of road. Discussion followed with Estes as to how the deputies would be able to patrol that activity without knowing which trucks any lifting of load limits had been lifted. Sand made a motion to allow KDO to haul trucks on County Road #5 east of Oakes with weight restrictions of 90,000k until July 1st as an overweight permit, waiving all fees because of his willingness to maintain the road and their past history of maintaining the road. Hokana seconded. Roll call vote with Sand yes, Hokana yes, Hamar no, Simek no, Roberts yes. Motion carried.

German spoke with the Commission concerning the county allowing residents to assist with maintenance of the roads, as the current state of the roads is not good. Discussion followed concerning the liability issue of someone else doing work on county roads. Hamar stated that something would have to be worked out with the Highway Department so that not just anyone is out doing the work. No action was taken.

Overtime call in charge was discussed. Sheppard read the motion originally made in December, which included a sunset clause of May 1st, which is the day in question. The original motion was to pay a call in for those cases where help was needed, and not because the whole staff was working overtime. Sand made a motion to pay the highway employees with the current policy, not including working overtime on the weekends. Simek seconded. Roll call vote with Sand yes, Hokana yes, Hamar yes, Simek yes, Roberts yes. Motion carried.

Radermacher updated the Commission on information she had received concerning the power pole issue with MDU. MDU has stated they are willing to sign an agreement to accept liability if something were to happen before the poles are pulled. MDU feels they should be able to be here next week to pull the poles. Their question was how much the county wanted the ditch wrecked to pull the poles. Commission felt that was the problem of MDU, and not the County.

An update was given on the current state of Covid in North Dakota. Large scale testing has been discussed. Holm and Miller stated they felt the travel restrictions will be lifted soon. A draft of reopening was shared with the Commission. Flaherty asked for clarification on returning to full staff. Commission stated that each office will need to address that individually.

Hokana made a motion to adjourn at 3:55.

**Special Commissioner Meeting via Zoom
May 8, 2020**

Chairman Marke Roberts called the meeting to order at 2:00. Present were Dean Simek, Joel Hamar, Thor Sand, and Chairman Marke Roberts. John Hokana was not present at the start of the meeting. Also present were employees Jeff Hagen, Chris Estes, Kim Radermacher, Danielle Dinger, Andi Schimke, Cresta Miller, Shirlene Wagner, and Kelly Schmidt.

Roberts requested Sheppard read the e-mail sent by Charlie Russell May 7th, concerning his resignation of the role as the FEMA Applicant Agent. Discussion followed concerning the job description of Russell's position. The question is if Russell is resigning from a portion of his job or the complete job.

John Hokana joined the meeting at 2:22.

Radermacher advised the Commission that she felt until the Commission could speak with Russell. More information is needed, including a review of the job description.

Hokana made a motion to table the issue until Roberts can connect with Russell and set up a time that the Commission can meet with him. Sand seconded. Roll call vote with Sand yes, Hokana yes, Hamar yes, Simek yes, Roberts yes. Motion carried.

Hokana made a motion to adjourn at 2:41.

**May 12, 2020
Special Commissioner Meeting**

Chairman Marke Roberts called the meeting to order at 9:06. Present were Thor Sand, John Hokana, Joel Hamar, Dean Simek, and Chairman Marke Roberts. Also, in attendance were employees Cresta Miller, Andi Schimke, Don Flaherty, Kerry Waldo, Danielle Dinger, Amber Miller, Lauri Wang, Abby Gibbs, Kim Radermacher, Shirlene Wagner, Jeff Hagen, Charlie Russell, and Chris Estes. Also present were residents Andy Seyer, Leroy Mehl, and Caden Coleman.

Hamar spoke to those in attendance concerning the need for Commission to return to the portfolio assignments from the beginning of the year. If there is an issue for the highway department, the portfolio for the Highway should be contacted. Issues that arise should be handled locally and not by contacting state employees.

Russell stated that he is withdrawing his resignation as FEMA applicant agent and that he will continue to perform those tasks. Discussion followed concerning the state of the relationship with state FEMA.

Discussion followed concerning gravel that Seyer had given permission to be used to fix roads, including FEMA projects. In order for that gravel to be used, the gravel needs to be approved by SHPHO in order for it to be approved for FEMA projects and the Seyer pit has not been certified.

Discussion followed concerning the issue on Dickey County #3, which is impassable for any emergency vehicles. Possible solutions, including draining water to the Jackson Township drain was discussed. A decision needs to be looked at to figure out if the county road is repaired or the township road is built up to allow emergency access. The buildup of the road could begin without the certification of the Seyer pit, as there is other gravel on the east side of the county. Discussion followed concerning who would pay for the certification of the pit. Hamar asked if our engineering firm, KLJ, needs to get involved.

Hamar made a motion to have the survey completed on the Seyer pit, with Seyer's permission. The survey is usually good for a year. Simek seconded. Roll call vote with Hokana yes, Hamar yes, Simek yes, Roberts yes, Sand did not vote. Motion carried.

Discussion followed concerning draining of the water to the Jackson Drain. Residents had spoken with John Quandt concerning the project. Quandt had stated that the project could be done for at least \$150,000. Discussion followed that the water is up to the railroad tracks and that some of the cost could be shared with the railroad company. The decision was made to get the road open for emergency travel only and to have it signed for no truck traffic. The drain will be looked at after that.

Hamar made a motion for Dickey County, in cooperation with Bear Creek Township, to open the road north of the cemetery to get the road open for emergency purposes. Simek seconded. -Roll call vote with Hokana yes, Hamar yes, Simek yes, Roberts yes, Sand did not vote. Motion carried.

Hamar made a motion to grant permission for the landowners and the water boards in Dickey County and Sargent County to complete a feasibility study on digging a ditch to the Jackson Drain to lower the water on Dickey County #3. Simek seconded. Roll call vote with Simek yes, Hamar yes, Roberts yes, Hokana and Sand did not vote. Motion carried.

Discussion followed concerning hiring a person to assist with the disaster paperwork for the four disasters Dickey County is currently in. Sheppard and Russell will develop an ad for the paper and will review with the Commission at the next meeting. The cost of the new employee will be offset by administrative money received from FEMA, along with grant money that can be received through an EMPG grant.

Discussion followed concerning grant money that could be used to assist in fixing the basement, specifically the renovations of the restrooms. Simek made a motion to sign the resolution of sponsorship for the grant. Hamar seconded. Motion carried. Roll call vote with Simek yes, Hamar yes, Roberts yes. Sand and Hokana abstained due to bad sound on the Zoom call. Motion carried.

Simek motioned to adjourn at 11:03.

**Commissioner Meeting
May 19, 2020**

Chairman Roberts called the meeting to order at 9:02. Present were Thor Sand, Dean Simek, and Chairman Marke Roberts. Joel Hamar and John Hokana were not present. Also present were Kim Radermacher and Kerry Waldo via Zoom.

Additions to the Agenda

MDU poles

Sand made a motion to approve the minutes from the meeting on May 5th, 6th, 8th, and 12th with corrections. Simek seconded. Motion carried.

Employees Shirlene Wagner, Danielle Dinger, and Don Flaherty joined the meeting at 9:15.

Simek made a motion to approve the vouchers, with the addition of \$567,170.56 to Sargent County to transfer funds from the Joint Water Board fund at Dickey County to Sargent County. Sand seconded. Motion carried.

Sand made a motion to approve the financials for April, 2020. Simek seconded. Motion carried.

Sand made a motion to sign the Memorandum of Agreement with 911 fee schedule for the 2021-2023 biennium. Simek seconded. Motion carried.

Sand made a motion to sign the ND DOT contract on the safety project with Strata Corporation. Simek seconded. Motion carried.

Radermacher updated the Commission on the status of the MDU poles in the County right of way. MDU has agreed to sign an agreement taking responsibility for any liability issues, while the poles are in the county right of way. Sand made a motion to grant the State Attorney's office the authority to enter into said agreement upon their approval of the wording in the agreement. Simek seconded. Motion carried.

Sheriff Chris Estes joined the meeting at 9:34. Estes updated the Commission on locations that had been looked at for relocation of the Sheriff's office during construction work to be done in the Courthouse basement. Discussion followed.

Residents Bryan and DeeDee Jacobson joined the meeting at 9:50.

Simek made a motion to open the mower bid hearing. Sand seconded. Motion carried.

Sheppard stated that four bids had been received. Bids were as follows:

Bidder 1 – M Aarvig	\$3,201.00
Bidder 2 – J Slickers	\$4,211.00
Bidder 3 – B Jacobson	\$4,200.00
Bidder 4 – G Bixler	\$3,800.00

Simek made a motion to accept the bid for \$4,211 from J Slickers. Sand seconded. Motion carried. Sheppard will contact the party and request a cashier's check or cash in the amount of the bid no later than May 27th. If payment is not received in time, the mower will be offered to the next highest bidder.

Simek made a motion to close the mower bid hearing. Sand seconded. Motion carried.

Sheppard presented two bids for the testing of the courthouse for asbestos and lead paint. This will need to be completed if the basement project is to be done. The quote included one price for just the basement, and also a price for the whole courthouse. Sand made a motion to proceed with quote from Legend Technical Services Inc. for the whole courthouse in the amount of \$5,835.00. Simek seconded. Motion carried.

A decision was made to review the overtime policy at a later date, when more Commissioners are present.

KLJ Engineer Brian Tykwinski, Highway Superintendent Jeff Hagen, along with residents Adam Seyer and John Quandt joined the meeting at 10:45.

Tykwinski updated the Commission on the site on County Road #1 where the water is over the road just west of Highway 11 on Dickey County #1. The site has been approved as an ER site. The project will need to be completed in 180 days from March 16th so work will need to be started on the project. The ER project will get the road out of water and a grade raise could be done after the ER site is fixed. Sand made a motion to give KLJ the permission to continue to proceed with the ER project. Simek seconded. Motion carried.

Simek made a motion to sign the two-year agreement with KLJ for general engineering services for the years of 2020-2021. Sand seconded. Motion carried.

Clerk of Court Andi Schimke joined the meeting at 10:50 to update the Commission on the status of plans for the reopening of county offices. The Committee will submit a plan that can be approved by the Commission.

Seyer updated the Commission on work done on Dickey County 3 east of Oakes. Landowners are requesting assistance in getting the road out of the water so that it is passable for emergency traffic. Discussion followed concerning making a temporary drain to get the water off the road. The landowners have agreed to share in about 20% of the cost, if the temporary drain were to be converted to a permanent drain.

Quandt provided information put he put together of the layout of the land and how the water would flow. Quandt also filled out the Application for Surface Drain application that would need to be turned in to the State Water Commission to get approval for the project. Discussion followed concerning the meetings of the Dickey, Sargent and the Dickey/Sargent water boards tomorrow. Quandt would like to present the application at the meeting if the Commission would agree to the project.

Quandt spoke with a contractor, and was given an approximate cost of \$185,000 for the whole project using buried pipe. The cost would be approximately \$40,000 cheaper if it was completed as an open ditch.

Simek made a motion of support for the project of an emergency drain on Dickey County #3 east of Oakes, with the assistance of the landowners and possibly the Railroad company. Sand seconded. Motion carried.

Commissioner reviewed the application for surface drain filled out by Quandt. Sand made a motion to sign the application for an emergency permit on behalf of Dickey County, upon the review and approval of States Attorney Radermacher. Simek seconded. Motion carried. Radermacher stated that the application is filed simultaneously to the local water boards and the state board.

Sheppard will forward the application to Radermacher for her review. Discussion followed on the requirement of the project being bid or not, considering the approximate bid received earlier. Radermacher will review the requirements in Century Code. Quandt stated he would also forward the information to Tykwinski for his review.

Hagen presented two permits to bore under County Road 1 and County Road 5 for rural water piping from Southeast Water User District and one permit from Charles Forward to excavate over County Road 14 for drain tile. Sand made a motion to approve the permits. Simek seconded. Motion carried.

Discussion concerning the lifting of load limits followed. Upon the recommendation of the Highway Superintendent Hagen, load limits were lifted on county roads, except for County #3 east of Oakes. Sand seconded. Discussion followed that Hagen had the authority to put load limits back on roads that may get damaged. Motion carried

Hagen had spoken with Bear Creek Gravel, concerning crushing some gravel in their pit. Bear Creek Gravel offered to crush more gravel, with the payment of said gravel to occur in 2021. Sand made a motion to allow Hagen to crush additional gravel with payment of royalty to be paid in 2021, for a maximum amount of \$100,000. Simek seconded. Motion carried.

Simek made a motion to adjourn at 12:45.
