

**Commissioner Meeting
January 3, 2023**

Commissioner John Hokana called the meeting to order at 9:00 am. Also present were Kacey Holm, Brandon Carlson, and Marke Roberts. Jerry Walsh was present via electronic means. Auditor Sheppard was also present. Clerk of Court Andi Schimke was also present via electronic means. The media was not present. The Pledge of Allegiance was recited.

Roberts made a motion to approve the draft of the minutes from December 20th and 28th with corrections. Carlson seconded. Motion carried.

Sheppard presented four quit claim deeds from parcels sold at the county tax sale in November, 2022 for signatures. Carlson made a motion to approve the signing of the deeds. Holm seconded. Motion carried.

Roberts made a motion to adjourn the meeting.

The meeting was reconvened.

Sheppard requested nominations for the position of Chairman for the 2023 fiscal year. Roberts made a motion to appoint Hokana as Chairman. Holm made a motion to cease nominations and cast a unanimous ballot for John Hokana for Chairman. Carlson seconded. Motion carried

Hokana made a motion to nominate Jerry Walsh for Vice chairman for the 2023 fiscal year. Carlson seconded. Motion carried.

Sheppard presented the report for openings on various boards for the county. A decision was made to put an ad in the paper for the positions for Park, Weed, and Water Boards. The Planning Board will also be advertised, as the terms of all members have expired. Sheppard will send letters to those expiring this year a letter informing them of the ad in the paper. Holm agreed to serve on the South Central Dakota Regional Council, in place of Jerry Walsh.

Discussion followed concerning the use of portfolios for the Commission. In the past, there was a portfolio for the Courthouse, the Highway Department, and the Health District. A decision was made to continue without portfolios, as done in 2022. Employees can contact any Commissioner with issues.

Sheppard presented additional vouchers in the amount of \$6,224.71 for overpayment of taxes. Carlson made a motion to approve the vouchers with the additional overpayment of taxes. Roberts seconded. Roll call was unanimous. Motion carried.

Walsh informed the Commission that the current microphone system is working better than the past. However, Holm and Sheppard are hard to hear. Sheppard will check with IT consultant Nelson about purchasing additional microphones.

Sheppard presented the rental agreement for the motor grader to replace the motor grader that is currently being repaired, along with the yearly agreement for Software Solutions, and South Central Dakota Regional Council for signature. Roberts noted that the contract for the motor grader includes sales tax. Walsh made a motion to sign the agreements with the exclusion of tax on the RDO contract. Roberts seconded. Roll call was unanimous. Motion carried.

Sheppard reported to the Commission that there were several employees who were unable to use all their vacation time by the end of the year, because of the offices being closed due to the weather. Roberts made a motion to extend the time to use their 2022 vacation to the end of January, 2023. Holm seconded. Roll call was unanimous. Motion carried.

Carlson reported to the Commission that the Weed Board has agreed to allow the Sheriff's office to store equipment. The trailer and mower that are parked inside the building would need to be parked somewhere else. The Highway Department already has a key. Holm stated there would be room at the fairground, as well. Carlson will update Estes on the conversation.

Walsh discussed with the Commission about an e-mail he had received from someone who has applied for heat assistance three months ago. The resident still has not heard from Human Services and is being told their electricity will be shut off. Information had been received that heating assistance applications were behind approximately 3 months. Walsh will contact Zone Director Michelle Massett concerning the issue.

Discussion followed concerning the response the County Commission have had for their response to the CO2 pipeline that has dominated many Commission meetings in the last two months. Discussion included the judicial implications that needs to be considered in any actions taken by the county. A decision was made that a compilation of a letter to address to the Public Service Commission with our concerns about the carbon pipeline. States Attorney Radermacher will be given the information discussed.

Highway Superintendent Jeff Hagen and DES/911 Coordinator Charlie Russell joined the meeting at 10:50.

Hagen stated that it will be six to eight weeks to get the motor grader fixed, due to the transmission being out.

The bridge signs on County Road 8 a mile south of Fullerton have been put up. The letter to Interstate Engineering has not been sent, waiting for the approval of the letter from the States Attorney.

Walsh requested information from Hagen on the listing for a job opening due to the retirement upcoming of Lematta. Hagen stated that the job has been posted at Job Service but has not had any applications.

Russell presented a resolution to declare an emergency because of the large amount of snow already received. Holm made a motion to sign the resolution. Carlson seconded. Roll call vote was unanimous. Motion carried.

The meeting went into recess at 11:50 for lunch.

The meeting reconvened at 1:30 pm. A list of those in attendance are on record at the County Auditor's office.

Mike Klipfel, a landowner of Dickey County, discussed with the Commission on the legal options for a moratorium and the setbacks for the CO2 pipeline. Discussion also included the rights of landowners that are right next to the area near the pipeline. Klipfel stated that the Burleigh County States Attorney stated that his opinion is that the County could use the setback requirements for the right-of-way could be used for the issue of setbacks for the pipeline.

Dennis Feichert, prior Commissioner from Brown County, stated he want to encourage the Commission to use the power they have and stop the construction of the pipeline in Dickey County. Feichert encourages the county to not be afraid of being sued and to do something, such as put a moratorium in place now. Brown County put on a moratorium in April. The question is what does the pipeline do to the land values and what does the pipeline do to the budget needed for emergency management.

Discussion included the urgency in putting something into place. Any correspondence sent to the Public Service Commission (PSC) needs to be received within ten days of the hearing. A hearing has not been set at this point. Sheppard read the notice received today concerning the application filed with the PSC by Summit Carbon Solutions. The notice states that hearings cannot be set until 45 days after the date of the notice. If the County were to submit information to the PSC, it has to be received within ten days of the hearing.

Mark Lapka, a farmer from Leola, reminded the Commission that they do have the authority to take action. The threat of lawsuits are large. His deceased grandmother is being sued.

Ed Fischbach, from Spink County, stated that the Commission unanimously passed a moratorium and are currently working on an ordinance. Fischbach stated that their county is being sued. Fischbach reminded the Commission that they are taking something from the landowners and are going to make money off of it. Fischbach feels that it would be a good idea to pass a moratorium today, which would allow the County time to work on an ordinance. Fischbach stated that in his opinion, the rush is to get the pipeline in before the regulations are put in place. Fischbach stated that Spink County would share their moratorium if a call was made to the office.

Linda Gayman is concerned about the water stream and the affect the pipeline could have on the stock ponds close to the pipeline.

States Attorney Kim Radermacher joined the meeting at 1:55.

Michelle Mueller asked how can a pipeline be put in when they don't know how to regulate it yet. Gary Hoffman, Dickey County landowner, seconded everything stated earlier. Hoffman is requesting that the Commission stand up for their landowners.

Roberts asked Lapka about the wording of their moratorium. Lapka stated that it is for hazardous liquid pipelines. Discussion included the fact that the moratorium does not stop the surveying being done, but stops the construction.

Fischbach stated that the County should watch surveying that is being done. Because landowners are not letting them on the land, the surveyors are drilling a hole in the middle of the intersection and surveying from the road. Gayman showed a picture where this has occurred in Dickey County.

Hokana assured those in attendance that the county does have concerns. Discussion followed concerning if there is any teeth in the moratorium, as it stops construction when construction has not started. The Commission doesn't want to control individual landowner rights. The Commission is concerned with the right of the county land and our county roads. Discussion followed concerning requesting a contingency fund set up with money paid to the County from SCS for issues caused by the pipeline in the future and a map of where the pipeline is going.

Feichert stated that there is nothing in their paperwork that discusses a contingency fund. Feichert also stated that there in nothing in the paperwork for decommissioning of the pipeline.

Discussion continued concerning the current law suits against counties that have been filed. Radermacher stated that there is no timetable on the lawsuits, as no hearing dates have been set.

Roberts asked Radermacher about the lawsuits, the moratorium, and the permitting fees. Radermacher stated that the lawsuit paperwork states that the permitting fees are too grievous and

therefore not lawful in Emmons County. The lawsuits for Spink, Brown, and McPherson Counties are stating the moratoriums are not legal. As stated, the moratorium is stopping construction, which is not happening at this time.

Discussion followed concerning the burden placed on all residents of the county and the pipeline only affecting the south part of the county.

A decision was made to send correspondence to the PSC with our concerns on the pipeline. The correspondence will be finalized at the next Commissioner meeting.

Carlson motioned to adjourn at 3:15.

Commissioner Meeting January 17, 2023

Commissioner John Hokana called the meeting to order at 9:45 am. Also present were Jerry Walsh, Kacey Holm, Brandon Carlson, and Marke Roberts. Auditor Sheppard was also present. The media was not present. The Pledge of Allegiance was recited. Summit Carbon Solutions (SCS) representative Jeff Skaare was also present. Clerk of Court Andi Schimke and States Attorney Kim Radermacher were also in attendance via electronic means.

County Ordinances

Roberts made a motion to approve the draft of the minutes of January 4th with corrections. Holm seconded. Motion carried.

Sheppard presented two additions in the amount of \$\$12,968.73 to Divide Township for FEMA reimbursement and \$22,147.22 to the Dickey County Treasurer for payments received for mobile home taxes. Walsh made a motion to approve the vouchers. Holm seconded. Roll call was unanimous. Motion carried.

Carlson made a motion to approve the December 2022 financials. Roberts seconded. Motion carried. Roll call was unanimous. Motion carried.

Tax Director Don Flaherty joined the meeting at 10:00. Flaherty informed the Commission of a parcel discussed at the January 3rd meeting for omitted tax was in error. No action was taken.

Flaherty discussed an agreement presented earlier for the maintenance agreement with Vanguard Appraisals for an extended service contract, locking in the yearly cost for five years. Walsh made a motion to sign the agreement. Holm seconded. Roll call vote was unanimous. Motion carried. Commission requested a list from Sheppard of technology agreements that the County has.

County Agent Breana Kiser joined the meeting at 10:00 to show the Commission the spray case purchased at the end of December. Kiser also reminded the Commission of the annual review completed by NDSU, which is scheduled for January 31st.

Carlson informed the Commission that Ludden Sports Club is sending a letter to the ND Game and Fish requesting permission to install a boat landing at Tad Lake. The Club is requesting a letter be sent by Dickey County as well. Roberts made a motion to have the Chairman sign a letter of support for the installation of a boat landing at Tad Lake. Walsh seconded. Motion carried.

Sheriff Chris Estes joined the meeting at 10:10.

Starion Insurance representative Dustin Maier joined the meeting at 10:15 to discuss the current level of liability insurance the county has. Discussion followed concerning the question of needing to increase the coverage Dickey County currently has from \$2,000,000 to a possible \$10,000,000. Maier informed the Commission on what this coverage offers. Discussion also included the increase in the cost of everything and what is an appropriate amount of coverage. Walsh made a motion to increase the liability insurance from \$2,000,000 to \$3,000,000. Roberts seconded. Roll call vote with Carlson yes; Holm no; Roberts yes; Hokana yes; Walsh yes. Motion carried.

Highway Superintendent Jeff Hagen and DES/911 Coordinator Charlie Russell joined the meeting at 10:35. KLJ engineer Bryan Tykwinski joined the meeting at 10:45.

Sheppard presented the budget amendments as shown below. Walsh made a motion to approve the budget amendments for the 2022 budget year. Carlson seconded. Roll call was unanimous. Motion carried.

Roberts discussed with the Commission his list of ordinances Roberts feels should be put in place by Dickey County concerning hazardous pipelines, in order to give the County and its residents some protection. They are:

- 1) Pipeline cannot be located within 440 yards of an occupied or unoccupied residence or stockyard or livestock lot.
- 2) Pipeline cannot cross a county road without a permit from the County Commissioners. If approved, the pipeline would be installed at a depth of 10 feet through the road, as well as the length of the right-of-way. Permit would need to be filed with the Commission at least 45 days before the pipe would be installed.
- 3) SCS will give \$25,000 per year to Dickey County as a contingency fund for the life of the project for the coverage of uncovered contingencies of the pipeline. The first installment would need to be made within 15 days prior to the start of the construction of the pipeline.
- 4) SCS will carry liability insurance and accept all liabilities for anywhere that they cross a county road. No surveying will be done on county roads without prior approval of the county.
- 5) Penalty for noncompliance is \$1,000 per day until corrected.

Razor Tracking representatives Jason Meixner and Nathan Hirte joined the meeting at 11:00 via electronic means.

Skaare responded to the list of ordinances brought to the Commission by Roberts. Skaare stated that the easement indemnifies all land owners. Skaare stated that ordinance one exceeds the safety requirements. Skaare discussed housing in Bismarck that is closer than the 440 yards, as suggested. Skaare felt that the road crossings were not unreachable. Discussion followed concerning the taxes received on the pipeline and the contingency fund mentioned in number three. The administration of the contingency was also discussed.

Hokana requested that Skaare talk with Roberts and Radermacher concerning the ordinances. Holm reminded those in attendance that the houses in Bismarck were built after the pipeline was installed, so the residents had a choice, while our residents do not.

Estes reported that a new deputy has been hired and will start the beginning of February. He is licensed and will be stationed out of Ellendale.

Tykwinski discussed traffic options for the bridge on County Road 8, south of Fullerton. Tykwinski will submit a plan to limit traffic by placing stop signs and only allow one lane traffic to the ND DOT. Tykwinski will also submit the bridge for bridge funding through the state.

Hirte presented information to the Commission concerning what Razor Tracking could offer to the county on the road equipment. The current motor graders have JDLINK installed on them. The Razor Tracking would be in addition to the JDLINK. The cost for the Razor Tracking is \$299 a month per piece of equipment for the first year and is \$239 a month after that. GeoFence was also discussed, which could also track activity in the area around the building, which could help with theft. No action was taken.

Hagen informed the Commission of his findings on the cost of blading to the townships. The County is currently charging \$125 per hour for blading and Hagen is suggesting \$180 per hour or \$60 a mile. This includes the large increase in the cost of equipment and fuel. Walsh made a motion to charge townships \$180 per hour or \$60 per mile for the 2023 season. Carlson seconded. Roll call was unanimous. Motion carried.

Treasurer Wonada Lematta joined the meeting at 12:30.

Lematta discussed with Commission interest rates she has received to place the Prairie Dog Fund money received today, along with other funds for a six-month CD. The best rate received at this time is BankNorth for 4.16%. Carlson made a motion to put \$2,000,000 in a CD for 6 months at the financial institution with the highest quoted rate, which at this time is Bank North. Holm seconded. Roll call was unanimous. Motion carried.

Sheppard presented the revised purchase order for the JD mower for the Park Board. The quote is higher than the quote received in 2022, as the mower received is a 2023 mower. Walsh made a

motion to sign the new purchase agreement. Roberts seconded. Roll call with Walsh yes; Hokana yes; Roberts no; Holm yes; Carlson no. Motion carried.

Sheppard requested a decision on the price of liquor license applications for those outside of city limits. Holm made a motion to keep the fees at \$200 for liquor license and \$100 for beer license. Walsh seconded. Roll call was unanimous. Motion carried.

Carlson reported on a phone call received concerning a winery that is being put in place behind the golf course. The request is for assistance in installing box culverts in the section line. A decision was made that the Water Board should be contacted. Holm also questioned if South Central Dakota Regional Council could also assist with this. Holm will check into that.

Sheppard presented a contract with Software Innovations for maintenance on our accounting software. Carlson made a motion to sign the agreement. Walsh seconded. Roll call vote was unanimous. Motion carried.

Discussion followed concerning the legislature currently in session. Walsh stated he had received information that the Juneteenth holiday is on Governor Burgum's desk, which could affect the county holiday schedule.

Walsh made a motion to adjourn at 1:30 pm.
