

**Commissioner Meeting
February 7, 2023**

Commissioner John Hokana called the meeting to order at 8:39 am. Also present were Kacey Holm, Jerry Walsh, and Brandon Carlson, with Marke Roberts in attendance via electronic means. Clerk of Court Andi Schimke, Administrative Assistance Colleen Rithmiller, Deputy Auditor Stormy Bertsch, and County Agent Administrative Assistant Shirlene Wagner were also in attendance via electronic means.

Additions to the Agenda
Fullerton bridge update
County Road 14

Holm made a motion to approve the draft of the minutes from January 17th with changes. Carlson seconded. Motion carried.

Walsh made a motion to approve the vouchers as submitted. Holm seconded. Roll call was unanimous. Motion carried.

Sheppard presented the applications of liquor licenses received from the Oakes Golf Club and the Ellendale Country Club. Holm made a motion to approve the liquor licenses. Carlson seconded. Roll call was unanimous. Motion carried.

Sheppard presented a quote from Bradco Restoration Inc. for the repair of the front steps of the Courthouse at Door 1. Walsh made a motion to accept the bid from Bradco Restoration of \$92,040, as read. Walsh made a motion to accept the bid from Bradco Restoration in the amount of \$92,040 for the repair of the steps at door 1. Holm seconded. Roll call was unanimous. Motion carried.

Summit Carbon Solutions (SCS) representatives Charlie Adams and Amanda Hofer joined the meeting at 9:00. Hofer was in attendance via electronic means.

Schimke updated the Commission on the status of SB2277, relating to changing clerk of court staff to be state employees. Schimke also discussed with the Commission a suggestion for grant money to upgrade the bathrooms on the second level, with the addition of a private bathroom for the safety and privacy of the Judge, while here for court purposes.

County Agent Breana Kiser and Family and Community Wellness Agent Danielle Dinger joined the meeting at 9:20 to present their quarterly update.

SCS representative Estee Schmidt joined the meeting at 9:25, via electronic means.

States Attorney Kim Radermacher and WAPA representative Levi Olsen joined the meeting via electronic means at 9:40.

Sheppard presented a raffle ticket permit application for the Ellendale Country Club. The funds will be used to replace aging equipment. Holm made a motion to approve the permit, with the waiver of the fee. Walsh seconded. Roll call vote was unanimous. Motion carried.

Landowners Natanya Olson, Mike and Nancy Klipfel, Gary and Elaine Hoffman, and Michelle Mueller joined the meeting at 9:50. Olson spoke to the Commission on her concerns with the CO2 pipeline. Olson asked for information concerning what the Commission plans on doing concerning the pipeline. Olson asked if anything had been done on repairing of the holes dug in the road to locate the pins. Olson asked why there was no one reprimanded for drilling in the road without permission from the County. Radermacher stated that the drilling was to locate the pin only, and that any outstanding holes should be identified so that they can be fixed. The pins need to be located for surveying purposes only.

Olson stated concerns about calls to the Auditor's office as well as the States Attorney's office and not getting returned calls. Olson also stated that she feels she is losing her property rights, and doesn't understand the need for the pipeline.

Olson asked if the Commission knew of the upcoming public hearing concerning the Summit Carbon Solutions application to the Public Service Commission at the North Sargent Activity Center in Forman on March 28, 2023 and asked if any Commissioners were attending. The Commission were aware of the hearing and Walsh stated he is planning to attend. Commission updated the group on the letter that the Commission plan to file with the PSC before the hearing.

G Hoffman asked what the big hurry is to push everything through. Hoffman felt it would be better to make sure everything was done correctly and not push it through the process. A copy of the front page of the Bismarck Tribune was handed out showing an article in today's paper concerning the pipeline. M Klipfel stated he felt that the Commission could be effective at the PSC hearing. Klipfel stated he felt the county is the first and last offense for the landowners in Dickey County. The Commission stated that the PSC will be notified of our concerns before the meeting, by the letter that is being composed.

Adams discussed the legislation that is in session at this time concerning the pipeline. Adams spoke of several organizations that have spoken in favor of the pipeline in the sessions at the Capital. Adams talked about the many pipelines already in service across the United States. Adams reported they have 57.97% volunteer easements on the project for the 2024 start of the construction of the project. When asked, Adams stated Dickey County is at approximately 22%.

Discussion followed concerning the heat coming from the pipeline and the effect of the heat on the ground in upcoming years. The crop payments on the easement are for future years, but the group felt that three years of crop damage was insufficient. Radermacher stated that Skaare was going to send out a sample easement, but that has not been received.

Roberts discussed the issues to be presented to the PSC for the comment period for the PSC hearing on the pipeline. The discussion also included work to be done on the following concerning zoning and the pipeline. The zoning will be discussed at the next Commissioner meeting.

DES/911 Coordinator Charlie Russell joined the meeting at 10:25.

WAPA representative Levi Olson discussed the permission needed for the electric poles along County Road 3, as they are currently working on the permanent reroute of the temporary poles installed late last year. WAPA is also requesting permission to do Geotech testing where the poles are slated to be installed. Radermacher is requesting some changes to the agreement before signing. A decision was made to postpone until the next meeting.

The meeting went into recess at 10:40 and returned at 10:45. Treasurer Wonada Lematta, Highway Superintendent Jeff Hagen, and KLJ Engineer Bryan Tykwinski joined the meeting.

Lematta reviewed the 4th quarter pledge report. Carlson made a motion to approve the report. Walsh seconded. Roll call was unanimous. Motion carried.

Sheppard presented the quit claim deed for parcel #08412000 which was not sold at the tax sale in November. The deed is recording the transfer of the parcel to the city of Ellendale. Walsh made the motion to sign the deed. Holm seconded. Roll call vote was unanimous. Motion carried.

Commission reviewed the various board assignment.

Holm made a motion to reappoint Keith Hauk to the Water Board. Carlson seconded. Roll call vote was unanimous. Motion carried.

Holm made a motion to reappoint Bob Schmidt to the Park Board. Walsh seconded. Roll call was unanimous. Motion carried.

Carlson made a motion to reappoint Trevor Hokana and Jade Ulmer to the Weed Board. Holm seconded. Roll call vote was unanimous. Motion carried.

Appointments for the Zoning Board will wait, until all legal requirements for representation on the Board are covered. This will be discussed at the February 21st meeting.

Tykwinski updated the Commission on the NDACo County Engineers conference. Tykwinski stated that bridge funding will be announced next week. Options for the bridge south of Fullerton were discussed. Approval by the ND DOT will need to be received before any changes can be made. Timing on getting the approval could be up to a month. Commission asked if any information had been received from Interstate Engineering in response to the information requested from the original project. No information has been received. Radermacher will send another letter to request a response.

Tykwinski has completed the preliminary engineering for County Road 12. Tykwinski will present the findings at the February 21st meeting.

Hagen reviewed the information with the Commission on the lease of the tractor through NDACo. The lease could be extended to a full year. Discussion also included the cost of including a snow blower with the tractor. Hagen will research the issue and report back at the next meeting.

A decision was made to sell the 1987 Oshkosh snowblower truck with a Cat D343 blower mower and a 3306 truck engine. The item will be listed on Bisman and open for bids. No minimum bid will be placed on the machine, but with the understanding that the county has the ability to accept or reject all bids.

Walsh discussed with the Commission an e-mail received from Razor Tracking. The County could have two units installed on a trial basis for a month or two to test the system. Roberts made a motion to test the Razor Tracking system on a temporary basis, at no cost to the county. Holm seconded. Roll call was unanimous. Motion carried.

Holm made a motion to adjourn at 12:25.

Commissioner Meeting February 21, 2023

Commissioner John Hokana called the meeting to order at 9:42 am. Also present were Jerry Walsh and Brandon Carlson. Kacey Holm, and Marke Roberts were unable to attend. Auditor Sheppard was also present. The media was not present. The Pledge of Allegiance was recited. Clerk of Court Andi Schimke and Summit Carbon Solutions representative Charlie Adams were in attendance via electronic means.

Walsh made a motion to approve the draft of the minutes from February 7th. Carlson seconded. Motion carried.

Carlson made a motion to approve the vouchers as presented. Walsh seconded. Roll call was unanimous. Motion carried.

Treasurer Wonada Lematta joined the meeting at 9:52. States Attorney Kim Radermacher, Deputy Tax Director Nicole Kempf, Administrative Assistant Colleen Rithmiller, and Summit Carbon Solutions representative Amanda Hofer joined via electronic means at 9:52.

Walsh made a motion to approve the January 2023 financials. Carlson seconded. Roll call vote was unanimous. Motion carried.

Discussion followed concerning the Special Park Board meeting scheduled for tomorrow, February 22nd at 10:00. If weather requires the closing of the courthouse, the meeting will still be held, through electronic means.

Tax Director Don Flaherty and Sheriff Chris Estes joined the meeting at 9:56.

Lematta requested a motion to update the signature cards for all accounts held by Dickey County, removing Lori Wald and adding Amy Mittleider. Wald will be working in the Records and Auditors offices from now on and Mittleider will be working in the Records and Treasurers offices from now on. Carlson made a motion to remove Lori Wald and to add Amy Mittleider. Walsh seconded. Roll call vote was unanimous. Motion carried.

Walsh made a motion to open the Abatement Hearing. Carlson seconded. Motion carried.

Flaherty presented three parcels for homestead credit abatement. Walsh made a motion to approve the abatements. Carlson seconded. Roll call vote was unanimous. Motion carried.

Carlson made a motion to close the abatement hearing. Walsh seconded. Motion carried.

Flaherty reviewed the 2022 sales ratios with the Commission. Based on the sales reports, the county is currently at a mean of 82.7% for residential sales and at a mean of 86.8% of commercial sales. The state requires the county to be within the mean of 90% to 100% of the current sales in Dickey County. Flaherty will make adjustments as required to achieve the average rate of 93% of the number, which is the goal for Dickey County for 2023.

Highway Superintendent Jeff Hagen joined the meeting at 10:31.

Radermacher joined the meeting in person to discuss the correspondence to be sent to the Public Service Commission concerning the Summit Carbon Solutions application. Discussion followed concerning the opinion of the two Commissioners not in attendance. Carlson made a motion to have Hokana sign the letter and have it forwarded to the Public Service Commission, after Radermacher contacted Roberts concerning the letter. Walsh seconded. Roll call vote was unanimous. Motion carried.

Sheppard presented the revised agreement with Western Area Power Administration concerning the work on the power lines along Dickey County Road 3, west of Oakes. Radermacher stated that the new agreement was as agreed upon. Walsh made a motion to sign the agreement. Carlson seconded. Roll call vote was unanimous. Motion carried.

DES/911 Coordinator Charlie Russell joined the meeting at 10:38.

Sheppard presented a liquor license transfer application for the Angry Beaver Lodge for a wedding in May at the Guelph Community Center. Walsh made a motion to approve the license. Carlson seconded. Roll call vote was unanimous. Motion carried.

A short recess was taken at 10:40 and returned at 10:46.

Russell updated the Commission on the winter weather that is scheduled to come today.

Interstate Engineering representatives Mike May and Darren Peterke joined the meeting at 10:50 to discuss the load limit issues on the bridge one mile south of Fullerton on County Road 8. Pictures were presented showing the state of the bridge beams during the construction. Included with the pictures is a letter from Interstate Engineering stating the commitment from Interstate Engineering to complete any repairs that should have been addressed during construction in 2021. Peterke felt that an update should be able to be given in April as to the status of the repairs.

KLJ Engineering Bryan Tykwinski joined the meeting at 11:05. Tykwinski stated that the plan to put the bridge on County Road 8 south of Fullerton to one lane until repaired has been submitted to the ND DOT. Tykwinski is hoping to have heard back by the next meeting, March 7th. Tykwinski felt the letter from Interstate Engineering was good news. This repair has been submitted as a bridge project through the state of North Dakota, as well.

Tykwinski presented an approximate cost of the work suggested to be completed to repair County Road 12. A graph of the bed of the road was shown as well. The project has been submitted for the highway safety program again this year.

Tykwinski updated the Commission on the timing of the completion of the bridge project northeast of Monango that was not completed in 2022. The vendor has stated the project will be their first project on their schedule this spring.

Hagen stated that his plan would be to use an outside source for the signing of Dickey County Road 8 during the road narrowed to one lane over the bridge. The highway department does not have all the signs required.

Walsh updated the Commission on the RazorTracking that has been installed on the Fullerton and the Ellendale blades. The RDO representative Shane Glover will be at the highway shop on Monday, February 27th at 9:00 to demonstrate what information the Commissioners can get from the JDLINK and how the RazorTracking works with the JDLINK.

Discussion followed concerning the motor grader that is being replaced this year. The discussion included the possibility of purchasing the motor grader at the end of the lease. Hagen will speak with Glover about the possibility.

Carlson informed the Commission on a call he received from a landowner who had been given permission to bore under County Road 12 last year. The landowner would like permission to possibly cut the road, as the contractor feels boring the road will not work. The landowner stated he would repair the road once completed. A decision was made to have the landowner attend the next meeting if he would like to request cutting the road.

Carlson motioned to adjourn the meeting at 11:55.
