

**Commissioner meeting  
April 3, 2023**

Commissioner John Hokana called the meeting to order at 9:05 am. Also present were Jerry Walsh, Kacey Holm, Brandon Carlson, and Marke Roberts. Auditor Sheppard was also present. Clerk of Court Andi Schimke, States Attorney Kim Radermacher, Health District employees, and Recorder Kelly Schmidt were present via electronic means.

Treasurer Wonada Lematta joined the meeting at 9:19.

Carlson made a motion to approve the draft of the minutes from March 21<sup>st</sup> with changes. Holm seconded. Motion carried.

Sheppard requested an additional voucher in the amount of \$512.49 to the city of Ellendale for utilities. Lematta is requesting the addition of \$100,000 purchase of a CD for the Water Resource Board. The current CD has a very low return and the Water Resource Board is considering cashing in the CD and putting it into another CD at a higher rate. The next water resource board meeting is not until April 19<sup>th</sup> and that decision will be made at their meeting. A question was made on a final payment, that Sheppard will review. No action was taken.

Schmidt updated the Commission on the Tyler Technology conversion in the Records Office. The new software will go live in April. Dickey County will start to accept e-recording of deeds. Schmidt discussed with the Commission about the charges that can be made for records requests with this new system. Commission feels that the cost should be comparable to other counties, as the county does have expenses into the system. No action was taken.

Roberts made a motion to approve the bills, with the addition of the City of Ellendale utility bills, the purchase of the CD once approved by the Water Resource Board, and the exception of the bill from Starion Insurance for the lease payment. Carlson seconded. Roll call vote was unanimous. Motion carried.

Roberts and Walsh updated the Commission on the meeting they attended concerning the Summit Carbon Solutions pipeline application to the Public Service Commission. There was sparse attendance of Dickey County residents. Sargent County Commission were there in support of the pipeline. Roberts spoke about zoning ordinances put in place by Jackson Township in Sargent County, which Roberts felt Dickey County should review and possible adopt, before the zoning board is put in place. Roberts feels action needs to be taken sooner than the zoning board would be able to accomplish. Sheppard will try to get a copy of this ordinance.

Land owner Steven Juelke joined the meeting via electronic means at 9:50.

Roberts made a motion to open the abatement hearing. Holm seconded. Motion carried

Tax Director Don Flaherty joined the meeting at 10:14. Juelke updated the Commission on the status of the house in question. The house has damage, as there was a fire in the basement. Juelke's plan is to fix the house and resell it. The house is currently not inhabitable. Flaherty's recommendation would be to adjust the value, as he feels the value is too high. The house needs extensive work to make it livable. The current value on the property is \$48,900, and Juelke's request is \$21,400 in total taxable value. After much discussion, Roberts made a motion to lower the value to \$32,000. Holm seconded. Roll call vote with Roberts yes; Holm yes; Carlson yes; Walsh no; Hokana yes. Motion carried.

Holm made a motion to close the abatement hearing, Carlson seconded. Motion carried.

Highway Superintendent Jeff Hagen joined the meeting at 10:20.

Carlson discussed with the Commission concerning the "colors" training offered by the County Agents office for all the county employees. Carlson made a motion to implement this mandatory training for all employees. Roberts seconded. Roll call was unanimous. Motion carried.

Sheppard presented a liquor license transfer application from the Ludden Tavern for a wedding reception at the Guelph Community Center in June. Sheppard has talked with Sheriff Estes so that he is aware of the event, which is not open to the public. Holm made a motion to approve the permit. Walsh seconded. Roll call was unanimous. Motion carried.

DES/911 Coordinator Charlie Russell joined the meeting at 10:35.

A copy of the zoning ordinances in place in Jackson Township were distributed to the County Commissioners, that were received from Sargent County.

Gravel hauling vendor Brad Retzlaff joined the meeting at 10:55 via electronic means.

Discussion followed concerning the gravel hauling bid opening that was to occur at 11:00 on April 4<sup>th</sup> will need to be moved to the April 18<sup>th</sup> meeting, due to the pending snow storm and the change in the date of the Commission meeting. The bids are due April 4<sup>th</sup> by 10:30 am. The current bids received cannot be opened before that time frame, which was clarified by Radermacher. Sheppard will put a notice in the paper with the new bid opening hearing in the newspaper before the next meeting. The submission date is the same, just a change in the bid opening.

Hagen updated the Commission on the weight limits on the bridge south of Fullerton. The official letter has been received to lift the load limits on that bridge and the signs will be taken down today. At the same time, highway staff will be putting in place signs for spring load limits that will be put on tomorrow April 4<sup>th</sup>.

Hagen presented a bill from Nelson International for the completion of the snow truck. The bill is in the amount of \$114,915.

Russell updated the Commission on the upcoming storm, arriving tomorrow.

Sheppard presented paperwork to be signed for additional opioid settlement funds.

Roberts made a motion to sign the contract. Holm seconded. Motion carried.

Roberts made a motion to adjourn at 11:45.

### **Commissioner Meeting April 18, 2023**

Commissioner John Hokana called the meeting to order at 9:00 am. Also present were Jerry Walsh, Kacey Holm, Brandon Carlson, and Marke Roberts. Auditor Sheppard was also present. The media was not present. The Pledge of Allegiance was recited. Deputy Auditor Stormy Bertsch, Clerk of Court Andi Schimke, and Asphalt Zipper representative Scott Freitas were present via electronic means.

Holm made a motion to approve the draft of the minutes from April 3<sup>rd</sup> with corrections. Carlson seconded. Motion carried.

Recorder Kelly Schmidt joined the meeting at 9:16 to give an update on the land record alert system, available with Tyler Technologies. Schmidt received a quote for \$11,700, which includes a yearly maintenance fee of \$1,200. This quote is good until October 8<sup>th</sup> with no cost to the user. Schmidt also informed the Commission that Dickey County Abstract Office has asked for all the images from the US Imaging scans completed in 2020. They are currently charged 10 cents an image, when documents are requested. Schmidt has compared what some other counties have done, and those that have been compared, charge \$1 across the board for anyone who walks in or calls for a non-certified copy and charge 10 cents to 50 cents per image with a 20 cent for indexing data per document. Dickey County Abstract would be required to supply a new drive, for the information to be downloaded. Walsh made a motion to change the fee for receipt of images from 10 cents to 20 cents for data requested by Abstract Companies, with an addition 20 cents when indexing data is requested per image, or the cost of 10 cents an image for the receipt of bulk data. Holm seconded. Roll call was unanimous. Motion carried.

Schmidt requested guidance from the Commission on the land record alert package from Tyler Technology. Walsh made a motion to approve the bid from Tyler Technologies of \$11,700 and to include the bid price in the 2024 budget. Holm seconded. Roll call was unanimous. Motion carried.

Sheppard presented an additional voucher for \$579.91 for Dakota Plains Credit Union for the County Agent's office. Holm made a motion to approve the vouchers with the additional voucher. Roberts seconded. Roll call was unanimous. Motion carried.

Roberts made a motion to approve the March 2023 financials. Walsh seconded. Motion carried.

Tax Director Don Flaherty joined the meeting at 9:50.

Roberts made a motion to open the abatement hearing. Holm seconded. Motion carried.

Parcel #03519750, when purchased, was an empty lot. The value of the property included value for a structure, which had been removed from the property prior to February 1<sup>st</sup> of 2022. This value of the structure was not removed, as should have been. Roberts made a motion to approve the abatement, as requested. Holm seconded. Roll call was unanimous. Motion carried.

Flaherty presented a disabled vet credit for a resident of Dickey County. Based on the date of the disability and the date of filing of the request, the adjustment would apply to the 2021 and 2022 tax years. Walsh made a motion to approve the disabled vet credit. Holm seconded. Roll call was unanimous. Motion carried.

Walsh made a motion to close the hearing. Holm seconded. Motion carried,

Carlson reported to the Commission of a problem with a 911 call from over the weekend that was not going through the correct channels. A decision was made to discuss with DES/911 Coordinator Charlie Russell when he attended the meeting.

Discussion followed concerning a meeting to be held at Growing Small Towns Wednesday April 19<sup>th</sup> at 12:00 pm concerning housing issues in Oakes. The issue of housing is county wide, but this meeting is specifically concerning the city of Oakes. Hokana and Carlson plan to attend. Commission requested information from Flaherty concerning taxing exemption possibilities for new housing. Sheppard called Flaherty back to the meeting and Flaherty explained the exemption possibilities in the county. The value limitation for exemptions is different in Oakes, compared to other towns in Dickey County. Discussion followed concerning the possibility of making a change to have all communities with the same limitations.

Highway Superintendent Jeff Hagen and DES/911 Coordinator Charlie Russell joined the meeting at 10:15. Summit Carbon Solutions representative Charlie Adams joined the meeting at 10:18 via electronic means. Resident Darrell Werre and KLJ Engineer Bryan Tykwinski joined the meeting at 10:23.

Adams had brought to the Sheppard's office the utility permits for the carbon pipeline crossing of county roads. The individual permits were reviewed by the Commission. There were six utility permits to bore under county roads and twelve temporary construction entrance location applications (approach applications). Discussion included the reference of cable on the utility permit, not pipeline. Roberts asked Adams if the new guidelines for pipeline safety have been released. Adams stated that they are compliant with the current standards and are not sure when the new standards will be released. Roberts requested information on the width of the bore and if it were only the width of the pipe. Adams stated he could check into that and get back to the Commission. Discussion was to table the subject until the date for new guidelines can be verified. Commission ask that the States Attorney review the application and the wording of pipe or wire be changed on the application. The Commission requested copies from Adams of other applications from the other counties for our comparison. Summit Carbon Solutions will be on the agenda for May 2<sup>nd</sup> meeting. Walsh made a motion to table the applications until the following meeting. Holm seconded. Roll call vote was unanimous. Motion carried.

Roberts made a motion to open the bid hearing for the full depth road reclamation machine. Holm seconded. Motion carried.

Only one bid was received in the amount of \$308,945 from Asphalt Zipper for a 720Xi-260H Reclaimer/Stabilizer. Deliver would be approximately 120 days. Walsh motioned to accept the bid from Asphalt Zipper in the amount of \$308,945. Carlson seconded. Discussion followed concerning the employees of the highway department being road builders or road maintainers. Sheppard will need to discuss with Asphalt Zipper financing options, as stated earlier by Asphalt Zipper. Roll call with Walsh yes; Hokana yes; Roberts no; Holm no; Carlson yes. Motion carried.

Holm made a motion to close the hearing. Carlson seconded. Motion carried.

Werre discussed with the Commission the bridge work being completed on County Road 6 east of Monango. Werre stated the bridge work is not completed and the water is over the bridge already. Werre felt that the bridge should have been lifted and the road built up so that the bridge would not go under water every year. Tykwinski stated that bridge is at the same elevation as prior but has been lengthened, which should help with the flooding issue. The bridge work is being done to NDDOT standards.

Dickey County Sheriff's Office joined the meeting at 11:15, via electronic means.

Residents Tim and Dennis Forward joined the meeting at 11:47 to discuss a permit approved in 2022 to bore under County Road 12 to install drain tile. The consensus of the contractor and the Forwards is that it cannot be bored. Forwards are requesting to trench it and replace the road surface after the work is completed. Based on the fact the County will benefit on County Road 5 with this tiling, Carlson made a motion to allow Forwards to cut the road, Roberts seconded. Roll call was unanimous. Motion carried.

Resident Brad Retzlaff joined the meeting at 12:03.

Holm made a motion to open the gravel hauling bids. Carlson seconded. Motion carried.

Bids were received Retzlaff Trucking LLC and Dakota Improvement. The bids were as follows:

Retzlaff Trucking for Sections 1 and 2 - \$2.80 per ton for 0-9 miles, 0.28/ton/mile for miles over 9, with loading trucks at 0.70/ton.

Dakota Improvement for Section 2 only – all miles at \$0.31/per ton

Holm made a motion to accept Retzlaff Trucking bid for Section 1. Carlson seconded. Roll call was unanimous. Motion carried.

Walsh made a motion to accept Retzlaff Trucking bid for Section 2. Holm seconded. Roll call vote was unanimous. Motion carried.

Carlson made a motion to close the bid hearing. Holm seconded. Motion carried.

Carlson made a motion to open the fuel bid hearing. Holm seconded. Motion carried.

The only bid received was from Farmers Union Oil Company for \$3.14/ gallon for 20,000 gallons of #2 dyed diesel fuel to be delivered to the Dickey County Highway Department. Walsh made a motion to accept the bid of \$3.14/gallon. Carlson seconded. Roll call was unanimous. Motion carried.

Roberts made a motion to close the hearing. Carlson seconded. Motion carried.

Discussion followed on the timing of the propane bid process. The current bid for the period of January through December. The current bidders have asked if that could be changed, as the length of the bid season is over two heating seasons, which makes it difficult to bid. Holm made a motion to change the propane bid period to be April 1<sup>st</sup> through March 30<sup>th</sup>. Roberts seconded. Roll call vote was unanimous. Motion carried.

Holm made a motion to include all county buildings in the propane bid, as the Fair Board and Weed Board are currently not included, with the two entities responsible for payment of that propane. Carlson seconded. Roll call vote was unanimous. Motion carried.

Tykwinski updated the Commission on the bridge east and north of Monango on County Road 6. As discussed earlier, the bridge is currently under water. The construction work will resume as soon as conditions are conducive. Dickey County Road 8 construction should start middle of May.

Sheriff Chris Estes joined the meeting at 12:30 and discussed with the Commission the patrolling for overweight vehicles. Estes is requesting overtime by his deputies to patrol for overweight trucks.

Hagen informed the Commission that Dakota Improvement is starting Wednesday, April 19<sup>th</sup> on cleaning the drain east of Oakes. The landowners involved with that drain will pay 20% of the cost back to the county to assist in this cost.

Hagen stated that the new motor grader was delivered today. Discussion followed concerning the plans for the existing motor grader and if the county would pay to keep the motor grader. RDO representative Shane Glover joined the meeting at 12:45 and stated the cost of purchasing that motor grader would be \$221,456. The motor grader is on lease through August, 2023 so the Commission has time to make a decision on this. Roberts made a motion to buy the motor grader before the end of the lease. Carlson seconded. Roll call vote was unanimous. Motion carried.

Walsh requested information from Hagen on the sand/salt building agreement discussed earlier with the city of Ellendale. Discussion followed about the need to get the contract finalized so that the county can begin to use the building. States Attorney Radermacher will be contacted to get the contract finalized.

Sheppard requested a motion to approve a payment in the amount of \$427,175 for the new motor grader that was delivered today. Roberts made the motion to approve the payment of \$427,175. Walsh seconded. Roll call vote was unanimous. Motion carried.

Russell discussed with the Commission the 911 issue in Lovell Township over the weekend. Russell is working with those involved to fix the problem.

Roberts made a motion to adjourn at 1:50.
