## Commissioner Meeting December 5, 2023

Commissioner John Hokana called the meeting to order at 8:30 am. Also present were Jerry Walsh, Kacey Holm, Brandon Carlson, and Marke Roberts. Auditor Sheppard was also present. The media was not present. The Pledge of Allegiance was recited. Clerk of Court Andi Schimke was also present via electronic means.

Additions to the agenda

Update on County Road #14A LaMoure County drain project meeting Update on staffing in Treasurer's Office

Holm made a motion to approve the minutes with corrections. Roberts seconded. Motion carried.

Carlson made a motion to approve the vouchers as presented. Holm seconded. Roll call was unanimous. Motion carried.

Veteran Service Officer Jean Haakenson and Substance Abuse Prevention Coordinator Abby Gibbs joined the meeting at 8:40.

Gibbs presented information to the Commission concerning funds received by Dickey County for settlements related to opioid litigation with various drug companies. Legislation during the 2023 legislative session in Century Code 50-36-06 states the county can transfer the funds received to the State Opioid Fund or transfer these funds to the Health District. Gibbs is requesting the funds already received and any future payments be transferred to the Health District. Carlson made a motion to transfer the funds already received and any future payments to the Health District. Roberts seconded. Gibbs will update the Commission on the use of the funds and complete any reporting required by the state on the use of the funds. Roll call was unanimous. Motion carried.

Health District Administrative Assistant Kerry Waldo joined the meeting via electronic means at 8:50.

Haakenson discussed with the Commission a proposal to combine the Veterans Service Officer position with LaMoure County, forming a full-time position. Discussion followed concerning how the costs would be divided. LaMoure County supplies a cell phone to this position, which could be reimbursable using the grant for the vehicle for transportation of veterans for doctor appointments. Walsh made a motion to entertain the combining of the Veterans Service Officer position for Dickey and LaMoure counties with an annual January 1<sup>st</sup> contract, splitting the cost equally and mileage paid by the County that the travel is being serviced, with Dickey County as the home office. Sheppard will request States Attorney Radermacher put together a contract. Holm seconded. Roll call was unanimous. Motion carried.

Health District Nurse Allyssa Moch joined the meeting via electronic means at 9:00.

Sheppard updated the Commission on staffing in the Treasurer's office. Lematta has hired a part time staff member to assist her until someone is hired full-time. Lematta is requesting extra hours during tax time. Commission stated their approval of the additional hours during tax time.

Schimke requested the changing of the signature card on the Clerk of Court checking account. The County accounts will not change until the deputy treasurer position has been filled. Holm made a motion to add the County Auditor and Deputy Auditor on the Clerk of Court checking account signature card. Carlson seconded. Roll call was unanimous. Motion carried.

Tax Director Don Flaherty joined the meeting at 9:20 to discuss the mobile home depreciation schedule for 2024. A comparison of the state numbers and Flaherty's recommendation were reviewed. Walsh made a motion to accept the Tax Directors recommendation and approve the depreciation schedule as presented. Holm seconded. Roll call was unanimous. Motion carried.

Sheppard presented the revised employee manual, with changes discussed early to take Social Services out of the employee manual. Walsh made a motion to approve the changes to the manual. Carlson seconded. Motion carried.

Commission reviewed the adjusted performance evaluation form. Discussion followed concerning which form to use, as one is not as complex as the other one. Adjustments were made to the simple form. Walsh presented an article from NDACo staff concerning the importance of performance reviews. Roberts made a motion to accept the evaluation form with amendments, which will be presented to department heads at the next Commission meeting. Carlson seconded. Holm stated he felt the form was too simple. Roll call was Walsh yes; Carlson yes; Holm no; Roberts yes; Hokana yes. Motion carried.

Sheppard stated the Credit Union is requesting a written document stating who has approval to request information on the county credit cards. Deputy Auditor Stormy Bertsch joined the meeting to state why she felt that the Auditor's office also needed approval to also request information on the credit cards. Walsh made a motion for Chairman Hokana to sign a letter stating department heads or the Auditor's office can request information on credit card charges. Carlson seconded. Motion carried.

Sheppard discussed with the Commission a decision to be made before the end of 2023, as to the precincts for the 2024 election. Discussion followed, but no decision was made. It was postponed until the next meeting.

DES/911 Coordinator Charlie Russell, Highway Foreman Jesse Filbert, Highway Superintendent Jeff Hagen, KLJ Engineer Bryan Tykwinski, and Sheriff Chris Estes joined the meeting at 10:33.

Sheppard requested the setup of the final Commission meeting to pay year end bills. A decision was made to set the meeting for Dec 27<sup>th</sup> at 11:00 am.

Tykwinski discussed with the Commission the application for the flexible funding application, which is due by December 31<sup>st</sup>. A review of possible road projects was completed. The projects included County #12, County Road #3 east of Oakes paving, and the balance of the County Road #8 south to Highway 11. Tykwinski stated the county could also ask for reimbursement for costs associated with grinding roads, as reimbursing the county for their costs is included as options for the funding. County Road #12 already had funding through the safety program, which could complicate applying for funds through this funding option. Tykwinski will put the applications together. Tykwinski stated that having letters of support for the projects would add to the applications. Sheppard will request letters of support from individuals along the roads that would be affected. Tykwinski requested clarification as to the county's financial commitment for each of the projects. Holm made a motion to state the county's financial commitment at 25% for all projects, except for County Road #8 at 20%. Walsh seconded. Roll call was unanimous. Motion carried.

DustPods representative Wayne Giles joined the meeting at 10:40 to discuss with the Commission their product. It is environmental-friendly alternative for road stabilization and dust control. The product. created by Giles, is a powder and should be applied to an already open road, as it binds the soil as a unit. The offer at the NDACo conference, which is good through the end of the year if the county purchases one mile, the next mile is free up to ten miles. Williams and Barnes Counties have purchased the product and LaMoure County is considering a purchase. If ten miles were purchased, the cost would be \$46,680. No action was taken.

States Attorney Kim Radermacher joined the meeting at 11:15.

The Commission discussed the trenching on County Road 14A. The water has gone down significantly. Holm discussed the piles of material on Travis Thompson and Bruce Skjefte's fields. The concern is the loss of farming by the two farmers because of the piles in their fields.

Carlson reported on a meeting in LaMoure concerning a drain project for Boom Lake by the city of Marion, which will drain into Bear Creek. The meeting is December 6<sup>th</sup> at 1:00 pm at the LaMoure County Courthouse and has a virtual link for anyone who cannot attend in person. Sheppard stated she will get the link from LaMoure County and forward to the Commission.

Holm made a motion to reimburse mitigating damages to Travis Thompson for five acres and Bruce Skjefte for three acres at \$1,000 per acre for the years of 2024 and 2025, because of the drain installed off County Road 14A. Carlson seconded. Holm stated for the record Thompson and Skjefte have not requested these funds. Discussion followed concerning the possibility of using Prairie Dog funds or ARPA funds to pay these mitigating damages. Roll call was unanimous. Motion carried.

Radermacher discussed with the Commission staffing issues within the States Attorney's office in surrounding counties. McIntosh and LaMoure Counties are without a States Attorney.

Holm made a motion to adjourn at 12:30.

## Commissioner Meeting December 19, 2023

Vice Chairman Jerry Walsh called the meeting to order at 8:30 am. Present also were Commissioners Kacey Holm and Brandon Carlson. Commissioner Marke Roberts was present via electronic means. Auditor Sheppard was also present. The media was not present. The Pledge of Allegiance was recited. Clerk of Court Andi Schimke and Substance Abuse Prevention Coordinator Abby Gibbs were in attendance via electronic means.

Carlson made a motion to approve the minutes from December 5<sup>th</sup> with corrections. Holm seconded. Motion carried.

Sheppard presented vouchers for \$16,057.57 for FEMA funds for two townships and Dickey County, along with a voucher for \$400,324.58 to Ellingson Water Management for the drain work completed by County Road 14A. Holm made a motion to approve the vouchers included the additions. Carlson seconded. Roll call was unanimous. Motion carried.

Holm made a motion to approve the financial report for November. Carlson seconded. Roll call was unanimous. Motion carried.

Sheppard discussed the grant available through the Department of Agriculture for the development of a comprehensive plan for Dickey County. A decision was made to call a special meeting for December 27<sup>th</sup> at 10:00 am and invite the Department of Agriculture and a representative from South Central Dakota Regional Council to attend so the feasibility of applying for the grant can be discussed. Discussion at the special meeting will also include the possible purchase of the DustPods product, a road stabilizing additive.

Schimke updated the Commission on the grant written to Court Administration for work to be completed in the courthouse in 2024. Schimke received a letter saying that each of the three projects needs a separate application. Carlson made a motion to sign the new applications. Holm seconded. Roll call was unanimous. Motion carried.

Holm discussed with the Commission the language related to the holiday granted to employees for their birthday. Sheppard said that in the past if your birthday fell on a holiday, the employee lost the birthday holiday. Holm made a motion to change the verbiage in the manual to say the holiday is a day in your birthday month. Carlson seconded. Roll call was unanimous. Motion carried.

NDSU representative Dena Kemmet, County Agent Breana Kiser, and Family Community Wellness Agent Danielle Dinger joined the meeting at 9:16 to discuss the posting of the Administrative Assistant position opening in the County Agent's office. Kiser, with the full support of Kemmet, is requesting the position be filled as a full-time position. Discussion followed concerning the budget for 2024, which has the position at half time. Sheppard presented the numbers at 50%, 80%, and 100%. Carlson made a motion to post the position at 32 hours per week, with the intent of increasing to full time in 2025. Roberts seconded. Roll call was Roberts yes; Walsh yes; Carlson yes; Holm no. Motion carried.

Tax Director Don Flaherty, Highway Superintendent Jeff Hagen, Sheriff Chris Estes, and DES/911 Coordinator Charlie Russell joined the meeting at 9:30.

Discussion followed concerning training for department heads ahead of the deadline for completion of performance evaluations. The original motion said the reviews were to be completed by February 28<sup>th</sup>. Carlson had a motion to amend the motion to include training by The Village for the department heads and change the completion date to 30 days after completion of the training or February 28<sup>th</sup>, whichever is latest. Holm seconded. Roll call was unanimous. Motion carried.

Walsh asked if there were any questions of the department heads in attendance. Schimke asked for clarification on what the procedure will be with the reviews. Walsh said that the reviews should be returned to the Auditor's office after they are completed. Sheppard will share the reviews with the Commission. Estes asked if they are yearly reviews or should they be based on the employees hire date. The Commission said it is a yearly review.

States Attorney Kim Radermacher joined the meeting at 10:20.

Roberts discussed with Radermacher and the Commission on the article received from Summit Carbon Solutions and a ruling from an Iowa court to allow the hazardous pipeline companies to set aside ordinances put in place against the hazardous pipeline and to follow federal guidelines. Roberts asked if it would affect North Dakota counties and Radermacher stated in her opinion, it should not. The ruling does not carry over into other states and doesn't give counties guidance in other states. Radermacher stated that in her opinion, the county should continue the path as discussed.

Roberts requested a clarification from Radermacher on the road crossing setbacks motion made earlier. Technically those were passed as a resolution and therefore are not ordinances. That motion pertained to the use of our roads, not zoning within the county. Resolution carries the same weight as an ordinance. The resolution covered the setbacks for county roads, and not the use of someone else's property.

Carlson made a motion to open an abatement hearing. Holm seconded. Motion carried. Flaherty said he received homestead applications from seven individuals, which involved tax years of 2022 and 2023. With the change in the requirements, Flaherty continues to receive applications. The individuals do qualify for the homestead credit. Holm made a motion to approve the abatements. Carlson seconded. Roll call was unanimous. Motion carried.

Carlson made a motion to close the abatement hearing. Holm seconded. Motion carried. Sheppard requested a decision on the election precincts for the 2024 election. Sheppard is requesting the county have one precinct for the whole county. Polling locations will be set in 2024. Holm made a motion to make the whole county one precinct. Roberts seconded. Roll call was unanimous. Motion carried.

KLJ Engineer Brian Tykwinski joined the meeting at 10:30.

Resident Haley Moen joined the meeting at 10:30 to discuss the water crossing on 86<sup>th</sup> Street north of the Oakes golf course. Moen is asking that the county apply for the flexible funding the state of North Dakota is currently accepting applications, to fix this water crossing. Moen said the research she had found concerning what has occurred on that road. The issue has been whose responsibility it is, the township or the county. The county would need to apply on behalf of the township to be considered for this funding. Moen discussed her research as to the cost of the project. Roberts made a motion for the county to apply for the grant for this project and the county would commit to a combined cost share of

20% with Bear Creek Township. Carlson seconded. Roll call was Walsh yes; Roberts yes; Holm no; Carlson yes. Motion carried.

ND Department of Transportation representatives Brad Darr, Jay Praska, Craig Faul, and Dickey County resident Joel Hamar joined the meeting at 10:40.

Darr stated that due to changes in legislation in 2017, a road corridor has been set up allowing truck traffic to a load weight limit of 129,000 pounds within that corridor. Additions can be made to the corridor by companies applying for a change in the corridor. Agtegra has requested the addition of Highway 281 from Jamestown to the North Dakota state line, as well as Highway 11 from Highway 281 to Highway 83 in Emmons County. Darr stated they are here to take any concerns or comments from all counties involved before a decision is made. Estes commented on current problems at the corner of Highway 281 and Highway 11 at the current load limits. Hamar said that he drives Highway 11 quite a bit and is concerned with the safety of all persons on the road if this would be approved. Discussion followed concerning the safety on Highway 281 versus the safety on Highway 11. Highway 281 is not as much of a concern as Highway 11. Holm made a motion to oppose the inclusion of Highway 281 from Jamestown to the state line and Highway 11 from 281 to Highway 83 in Emmons County. Roberts seconded. Ellendale City Mayor Don Flaherty said the city would concur with the opinion of the county. Roll call was Walsh yes; Roberts yes; Holm yes; Carlson no. Motion carried.

Russell presented a quote for the compilation of the multi-hazard mitigation plan presented by South Central Dakota Regional Council (SCDRC) for \$19,375. The plan must be updated by 2026. Carlson made a motion to sign the quote from SCDRC. Holm seconded. Roll call was unanimous. Motion carried.

Sheppard presented a request from Park Board President Cary Werts to reschedule the Park Board meeting to January  $16^{th}$  instead of January  $2^{nd}$ . A decision was made to move the Park Board meeting to January  $16^{th}$  and hold the meetings, including the Commission meeting, at the Dickey County Highway Shop. The Park Board meeting will start at 7:30, the Health District at 8:30, and the Commissioner meeting at 10:00.

Sheppard discussed with the Commission the need to make a motion selecting what form of currency will be accepted in Dickey County. Carlson made a motion to accept only US currency, due to the inability to place value on other forms of payment. Holm seconded. Roll call was unanimous. Motion carried.

Holm made a motion to adjourn at 11:45.

## Special Commissioner Meeting December 27, 2023

Chairman John Hokana called the meeting to order at 10:00 am. Present also were Commissioners Jerry Walsh, Kacey Holm, Brandon Carlson, and Marke Roberts. Auditor Sheppard was also present. The media was not present. The Pledge of Allegiance was recited. Administrative Assistant Amy Mittleider was present. Department of Agriculture representative Haylee Viger, and South-Central Dakota Regional Council (SCDRC) representatives Traci Redlin and Jennifer Schultes were present via electronic means.

Viger reviewed the current regional livestock development and planning grant program that the Department of Agriculture is taking applications for the funds. The County grant is \$12,000 and each township could receive \$500, if included in the application. The grant would help counties and townships with livestock development planning. Money from the grant reimburses costs incurred in the coordination of strategic planning and encouraging investment in livestock production. The county would need to pass a resolution and SCDRC would need to fill out the simple application on the Department of Agriculture website. The question discussed if the cost of the planning was more costly than the \$12,000 grant, whose responsibility is the excess. Viger stated she would check into that and let the Commission know.

Hokana discussed with Viger about the North Dakota Livestock Alliance and the fact this was not competing against the alliance. Viger and Schultes stated they have reached out to surrounding counties to check their interest in the grant program.

Carlson made a motion to sign the below resolution and apply for the grant. Roberts seconded. Discussion followed that SCDRC will apply, after the Commission signed the resolution. Roll call was unanimous. Motion carried.
