

**Commissioner Meeting
June 4, 2024**

Chair Jerry Walsh called the meeting to order at 9:00 am. Commissioners John Hokana, Brandon Carlson, Kacey Holm, and Marke Roberts were also present. Auditor Sheppard was also present. The media was not present. The Pledge of Allegiance was recited. Via electronic means, Clerk of Court Andi Schimke, Sheriff's office, Health District staff, and States Attorney Kim Radermacher were in attendance. Resident Cindy Bagley was also in attendance.

Holm made a motion to approve the corrected minutes. Roberts seconded. Motion carried.

Carlson made a motion to approve the vouchers as presented. Holm seconded. Roll call was unanimous. Motion carried.

Applied Digital representative Andrea Mireles joined the meeting at 9:10, to listen and better understand issues in Dickey County.

Holm discussed with the Commission the idea of having a Salary Committee review the current salary schedule and come back with recommendations for the Commission before 2025 budgets are finalized. Discussion followed concerning the members of that committee, which the Commission felt should involve all department heads that were interested in being involved. Sheppard will send an e-mail to all department heads, informing them. To fit within the guidelines in the budget process, a presentation would need to be made at the July 16th meeting. Holm stated he would be willing to work with the Salary Committee. Sheppard will work with Holm to get a meeting set that will work for anyone willing to assist in the process.

County Agent Breana Kiser and Family and Community Wellness Agent Danielle Dinger joined the meeting at 9:25 to review their quarterly narrative. Kiser also informed the Commission of several training opportunities that will require Kiser and Dinger to travel outside of North Dakota.

Carlson informed the Commission about a phone call he received from MaryAnne Kunrath with the Dickey County Historical Society. Kunrath is concerned about one of the area historical societies in Dickey County that are receiving some tax dollars that is not using the funds appropriately in her opinion. Sheppard will ask the Historical Society of Monango to attend the next meeting so that the issue can be discussed. Sheppard will ask for the breakdown of how the money is distributed from Kunrath before the next meeting.

Administrative Assistant Amy Mittleider joined the meeting at 9:35. Roberts requested that Mittleider check into the regional workforce impact grant discussed in the SCDRC newsletter. Roberts suggested maybe applying for grant money to put in place training for CDL license training for drivers in the local area. Mittleider will check into the possibility.

Sheppard presented an application for a gaming permit from Ellendale Country Club for a raffle to raise funds for a new lawnmower. Holm made a motion to approve the permit and waive the application fee, after the location of the drawing address is verified. Carlson seconded. Roll call was unanimous. Motion carried.

Sheppard presented an application for a transfer of the liquor license of the American Legion to the Cody and Deanna Sand Ranch on June 15th. Holm made a motion to approve the transfer to the Sand Ranch. Roberts seconded. Roll call was unanimous. Motion carried.

Sheppard reported on a request received from ND Dept. of Emergency Services asking for access to reporting for 911 fees received by month. Currently the county would report the number of lines per month and the new system with NDACo will give NDDDES the same information. Roberts made a motion to allow NDDDES access to the reports. Holm seconded. Roll call was unanimous. Motion carried.

Roberts made a motion to open the Pheasant Lake Park area debris removal bid hearing. Hokana seconded. Motion carried.

One bid was received from Holm Family Custom Chopping LLC in the amount of \$7,000 for all zones. The breakdown per zone was included. GPS coordinates for the placement of the debris are also given. The bid is only valid if all zones are approved.

Tax Director Don Flaherty joined the meeting at 10:05.

Hokana made a motion to accept the bid from Holm Family Custom Chopping LLC. Carlson seconded. Roll call was unanimous with Holm abstaining due to conflict of interest. Motion carried. The responsibility of verifying the project is completed will be done by the Park Board chair.

Carlson made a motion to close the hearing. Roberts seconded. Motion carried.

The Commission meeting went into recess and returned at 10:15. Sheriff Chris Estes joined the meeting at 10:15.

Holm made a motion to open the abatement hearing. Carlson seconded. Motion carried.

Flaherty stated that the abatement is on parcel #07249000, located in Valley Township. The parcel originally had a house on the property that was removed due to a parcel split. In error, the removed house has not taken off the original parcel, therefore the house was being taxed twice. This abatement will remove the second assessment.

Holm made a motion to approve the abatement. Hokana seconded. Roll call was unanimous. Motion carried.

Carlson made a motion to close the abatement hearing. Holm seconded. Motion carried.

Comstock Construction representatives Olivia Yost and Jason Flack joined the meeting at 10:20 to discuss the possibility of a detention center in Dickey County. The possible timeline and size of the center was discussed. Discussion followed concerning checking with the state to make sure that we have all the requirements of a detention center. Sheppard will ask Mittleider to research grants that the county could apply for to assist with the project. Estes will talk with surrounding counties on letters of support from each of them. Roberts discussed a feasibility study needing to be done to make sure it is feasible. Yost stated that normally the architect of the project does a feasibility study. Yost will get Dickey County a list of names of companies that could complete a feasibility study. No action was taken.

Dickey County Highway Superintendent Jeff Hagen & KLJ Engineer Bryan Tykwinski joined the meeting at 10:50.

Flaherty presented information to the Commission that will be used during the equalization meeting on Thursday. Minor adjustments to the commercial value have occurred, with more changes occurring in the residential areas of the county. Based on the calculations, Dickey County is within compliance, based on the requirements of North Dakota. Flaherty discussed an adjustment that was to occur in four townships in residential values. However, due to issues encountered in the process, the adjustments did not occur. The Commission requested that Flaherty complete that adjustment before the meeting Thursday, June 6th. Flaherty reminded the Commission of the Equalization Meeting Thursday at 1:00 pm for Cities and townships will follow.

Tykwinski updated the Commission on the County Road #12 project. The two grant programs where Dickey County has received funding for this project have been combined, allowing the project to be completed in one process. The bid hearing will be in 2025 and construction will occur in 2026.

Tykwinski presented an amendment to the County-Engineer agreement with KLJ. The original agreement expired May 17, 2024. This amendment will extend the agreement to May 17, 2026. Holm made a motion to sign the amendment. Carlson seconded. Roll call was unanimous. Motion carried.

Tykwinski presented a task order for the Divide Township project. This project is funded through the State. Carlson made a motion to sign the task order. Roberts seconded. Roll call was unanimous. Motion carried.

Carlson requested information on the temporary power poles that were installed by WAPA two years ago that the Commission were told they would be there one year. No one has heard anything about where the process stands. Sheppard will send a request for more information from WAPA and will forward the information once received.

Carlson discussed with the Commission the issue of fishing off the bridges on county roads. Hagen stated that signs have been put in place, but the signs are pulled out of ground and thrown into the river. Hagen will get signs put up on county road bridges stating no fishing off the bridge.

Sheppard stated a Dickey County landowner would like to purchase a parcel of railroad land that has been abandoned by the Railroad. Radermacher updated the Commission on the legal handling of the sale of this property. A decision was made to put all abandoned property parcels up for bid at the July 2nd Commission meeting.

Holm made a motion to adjourn at 11:45.

County Equalization Meeting June 6, 2024

Chair Jerry Walsh called the County Equalization meeting to order at 1:03 pm. Also present were Commissioners John Hokana and Kacey Holm. Also present were Assessor Rod Rodningen, Ellendale City Auditor Nicole Kempf, Tax Director Don Flaherty, resident Joel Hamar, and residents Carl and Holly Jo Kronberg. Auditor Sheppard was also present.

Chair Walsh turned the meeting over to Flaherty. Flaherty presented three reports for those attending to review. In 2023, the sales ratio median was 97.2% for commercial property and 86.6% for residential property. With adjustments made in 2024, the sales ratio median is currently at 98% for commercial and 93.3% for residential property. Dickey County is required by law to be in the range of 90% to 100% to comply with the State of North Dakota law. The report also shows the percentage for the city of Oakes and the city of Ellendale. Flaherty stated the state looks at the whole county. There is a significant increase in the residential values due to the state of the housing market in the county at the time. Commercial property has had only minor changes to their property values.

Flaherty asked if there was anyone that would want to speak concerning values in the cities of Dickey County.

H Kronberg stated they are requesting an appeal for the property they are purchasing in the city of Forbes. The true and full value of the property was \$28,800 in 2023. The true and full value for 2024 has been set at 106,100 and no changes have been made to the property. H Kronberg stated they had appealed the value at the local equalization meeting in Forbes. Discussion followed about her request that the state assess the house, as H Kronberg is not comfortable with anyone from Flaherty's office coming into her house. Carl K questioned the difference in assessed value versus appraised value. When asked what Kronbergs are requesting, H Kronberg stated they are asking the value to be lowered and any viewing of the property would have to be done by someone outside of the current tax equalization office. Rodningen was suggested as an appropriate person to do the assessment and H Kronberg agreed to that. Kronbergs and Rodningen will set up a time that works for both parties. Flaherty stated the city and H Kronberg had approved for former Deputy Tax Director Kempf to reassess the house, but H Kronberg had changed her mind about a week after the Forbes Equalization meeting. Discussion continued that the reassessment needs to be completed by the end of June. Rodningen would need to do the actual assessment by June 20th so that all paperwork would be completed by the end of June.

Hokana made a motion to have Rodningen reassess the house on parcel #11086000 in the city of Forbes by June 20th for a final value for the house, allowing Kronbergs to still appeal to the state equalization board if they feel the value is still too high. Rodningen will give the information to the Commission and the Kronbergs, as to the final value. Holm seconded. Roll call was unanimous. Motion carried.

No other residents from cities in Dickey County were at the meeting.

Flaherty discussed the values in townships in Dickey County. Agriculture land values are at 97.4% of the value required by the state of North Dakota. Flaherty discussed an adjustment that was to occur in Van Meter, Elm, Kentner, and Albion Townships that had not occurred. There had been an issue earlier that prevented the change from occurring. Flaherty presented the percentages to market value ratios once these adjustments were made and the County was still in compliance with the requirements of the state. Based on the recommendation of Flaherty, Holm made a motion to adjust the values in the four townships as shown. Hokana seconded. Roll call was unanimous. Motion carried.

Hamar voiced his concern on a commercial property at the Applied Digital plant that involves two hoop buildings, where the cement business is located. Hamar stated that cement is being sold to outside parties from that building. Flaherty stated that temporary buildings at building sites are not normally taxed but was not aware that they were selling to other parties. Flaherty stated that it will need to be handled as an omitted tax issue.

Holm made a motion to accept the valuations as presented, except parcel #11086000, which will be reassessed by Rodningen in June. Hokana seconded. Roll call was unanimous. Motion carried.

Holm motion to adjourn at 2:05.

Commissioner Meeting June 18, 2024

Chair Jerry Walsh called the meeting to order at 9:00 am. Commissioners John Hokana, Brandon Carlson, and Marke Roberts were also present. Auditor Sheppard was also present. The media was not present. The Pledge of Allegiance was recited. Residents Jeanette Robb-Ruenz, Cindy Bagley, and Applied Digital representative Andrea Mirales were also in attendance.

Carlson made a motion to approve the minutes for June 4th and June 6th with changes. Hokana seconded. Motion carried.

States Attorney Kim Radermacher Joined the meeting at 9:05.

Hokana made a motion to approve the vouchers. Roberts seconded. Roll call was unanimous. Motion carried.

Roberts made a motion to approve the May 2024 financials. Carlson seconded. Roll call was unanimous. Motion carried.

Tax Director Don Flaherty joined the meeting at 9:32. Flaherty informed the Commission that the value on the property in Forbes City has been lowered to a total true and full value 41,900 on parcel #11086000 after the reassessment completed by Assessor Rod Rodningen. Flaherty will send a letter to the landowner confirming the change in value.

Hokana made a motion to grant a holiday for the county employees for July 5, 2024. Carlson seconded. Roll call was Hokana yes; Roberts no; Walsh no; Carlson no. Motion did not pass.

Hokana requested that all Commission read the article he read concerning the shortage of jails and detention centers in the state of North Dakota. The article can be located at:

Carlson informed the Commission concerning his discussion with Jail and Justice Consulting representative Brad Hompe concerning planning and consulting assistance for Dickey County. Hompe will attend the July 2nd via electronic means to discuss the matter. Hompe was referred to Dickey County by Comstock Construction.

The meeting went into recess at 9:53 and returned at 10:05. Administrative Assistant Amy Mittleider joined the meeting.

Carlson informed the Commission about a conversation he had with Dan Spellberg from the Southeast Region Career and Technology Center in Oakes. Carlson informed Spellberg that the county was looking for grant funds for training CDL drivers in the area. Spellberg stated the center was also interested in this as well. Mittleider stated that she is looking into grant programs to help cover the cost. Discussion included requesting assistance from local industries that would take advantage of training such as this. Mittleider will continue to work on the grant applications for the project.

Sheppard presented an application for an annual gaming site for Hole-In-One Foundation, using the Oakes Golf Club as the gaming site. Roberts made a motion to approve the application. Hokana seconded. Roll call was unanimous. Motion carried.

DES/911 Coordinator Charlie Russell and Sheriff Chris Estes joined the meeting at 10:40.

Walsh spoke with the Commissioners concerning our response to the Covid epidemic. Walsh stated he feels we need to look forward to how we are going to respond to another epidemic or emergency. Some information given by the federal offices was inaccurate. Walsh stated he feels we need to be open minded if it occurs again. Roberts stated our health district employees had to follow the rules from the federal and state level. Commissioners acknowledge the great work that our Health District did at that time. However, Walsh felt our Health District Board should have been more deliberative on these directives. No action was taken.

Sheppard requested a date to be set for the review of budget for the fiscal year of 2025. A decision was made to start reviewing 2025 budgets the afternoon of July 16th. Further dates will be set when all board members are in attendance.

Highway Superintendent Jeff Hagen joined at 10:52. Health District staff joined the meeting via electronic means at 10:53.

Hagen discussed with the Commission how the LoadPass fees will be distributed with the townships that have signed on with LoadPass. Ellendale Township Chairman Joel Hamar will be attending the meeting on July 16th to discuss the issue. Options were discussed, such as using an 80/20 split between the county and township.

KLJ Engineer Bryan Tykwinski joined the meeting via electronic means at 11:01.

The Commission discussed County Road 3 east of Oakes and the complaint of dust from the road. Hagen stated he would suggest applying chlorine to the road, instead of reclaiming the road again with the Asphalt Zipper. Hagen will check on the price to apply the chlorine and report to the Commission.

Discussion followed concerning the County Road 14A drain and the need for gates to be installed. Dakota Improvement stated the work will start after July 4th.

Hagen reported to the Commission on the issue of crack sealing completed early this spring. The seal didn't adhere to the road surface, as there was moisture from the frost still coming out of the ground. The loose material has been picked up.

Hagen stated that he will be looking into crushing gravel this fall at the Musland pit. Discussion followed concerning the placement of gravel pits the county uses or owns. In reviewing parcels of land that Dickey County owns which is described as an abandoned gravel pit. Hagen will investigate these parcels.

Roberts made a motion to adjourn at 11:54.
