Carlson made a motion to approve the vouchers as presented, with the addition of the two vouchers. Hokana seconded. Roll call was unanimous. Motion carried.

Hokana made a motion to approve the August 2024 financials. Carlson seconded. Roll call was unanimous. Motion carried.

Walsh commended Janitorial staff Scott Peterson on the upkeep of the courthouse in preparing for the visitors from NDACo. Several of the visitors commented on the beauty of the building and landscape.

County Agent Breana Kiser joined the meeting at 9:26. Kiser presented the quarterly narrative put together by her office.

Kiser informed the Commission that the lease on their printer was up for renewal. Kiser presented the quote to replace the printer with a different printer, along with the cost of the buyout of the current printer. Carlson made a motion to approve the 60-month lease on a new printer. Roberts seconded. Roll call was unanimous. Motion carried.

Carlson updated the Commission on the use of the leafy spurge beetles placed this summer in his pasture. A change in the leafy spurge can be seen already.

Sheppard discussed with the Commission a vacuum that is at the Human Services Zone office that had originally been used in the Oakes office. Human Services doesn't need the vacuum and is requesting the authorization to donate the vacuum to a client that needs a different vacuum. Carlson made a motion to donate the vacuum to Human Services to donate it as they see fit. Roberts seconded. Roll call was unanimous. Motion carried.

Health District employee Kerry Waldo joined the meeting at 10:05 via electronic means.

Sheppard presented a form assigning the statutory duties of County Superintendent of Schools to County Recorder Kelly Schmidt. During training, Schmidt was informed that Dickey County had not filed the form. Roberts made a motion to sign the form designating Schmidt as the Superintendent of School designee for Dickey County. Carlson seconded. Motion carried.

The meeting went into recess at 10:10 and returned at 10:20.

Highway Superintendent Jeff Hagen joined the meeting at 10:20.

Sheppard presented a quote for the installation of insulation on the outside line to the heating/air conditioning units that service the Human Service office in the amount of \$428.00. Roberts made a motion to approve the quote. Carlson seconded. Roll call was unanimous. Motion carried.

Ellendale City Mayor Don Flaherty joined the meeting at 10:25. Flaherty is requesting a change in the location of a propane tank, as required by federal building codes. The propane tank will be within 200 feet of the new ambulance hall. The options for the propane tank are to move the tank so that it is not within 200 feet of the new building or build a concrete berm around the tank where it is currently located. The propane tank is used for the heating of the Human Services portion of the building. The city is asking that the tank be moved to the east or to place a berm around it. The city will pay for the work to be done. Discussion followed concerning the best option for the county. Walsh felt moving the tank was the best option. Carlson made a motion to authorize Hagen to work with the city to ensure the best option for all parties involved. Roberts seconded. The change will need to occur before heating season. Flaherty stated that the city ambulance hall project is on hold until this is completed. Roll call was Hokana yes; Roberts yes; Walsh no; Carlson yes; Holm yes. Motion carried.

Sheppard presented a revised performance review form for the Commission to review. 2024 reviews are due by December 15th and Sheppard would like to use the new form. All original subjects are still covered, but several have been combined with other subjects. Walsh informed the Commission that all elected officials have been informed that there will not be a written evaluation on their job

performance, but that a review of a salary increase will be done. A decision was made that all evaluations by the Commission will be completed by two Commissioners, when possible.

Hagen informed the Commission that the new snow truck on order for 2024 will not arrive until 2025. The price is locked in, but the build will not start until February 2025.

Discussion followed concerning County Road 3 west of Oakes. The city of Oakes resurfacing road project stopped approximately 400 feet from the spot where the county project started, leaving a stretch of road that is starting to break up. A decision as to what the county wants to do is urgent, as the contractor plans to be done and gone by September 25th. The contractor's grinder is already gone so the county would have to use the asphalt zipper to grind the road, if that is what they choose. An overlay could be done on that portion, and the need to grind the road to match was also discussed. Carlson made a motion to work with the contractor to get the 400 feet done. Roberts seconded. Roll call was unanimous. Motion carried.

Anliker Construction representative Troy Anliker and DES/911 Coordinator Charlie Russell joined the meeting at 10:45. Sheriff Chris Estes, Ellendale Township representatives Joel Hamar and Jerry Rekow joined the meeting at 10:50. Applied Digital representative Nick Phillips joined the meeting at 10:54 via electronic means.

Anliker discussed with the Commission the color of the tin to be installed on the building renovation. The quote received from Anliker to straighten the building and put the tin on the walls was reviewed. The cost and dimensions of a new door was discussed for the west end of the building. Roberts made a motion to approve the quote in the amount of \$66,500 for the purchase of the tin, installation of the tin and the straightening of the building, and the purchase and installation of a 3-inch 14x22 insulated door with opener. Carlson seconded. A door for the other end of the building was also discussed. Roll call was unanimous. Motion carried.

KLJ Engineer Bryan Tykwinski and resident Randy Sell joined the meeting at 11:00.

Sell presented a request for an easement on trees to be planted along County Road 5. Sell is requesting to plant the trees at 100 feet, not the 200-foot setback requirement. Hagen stated he felt it will not be a problem, as there are already trees there. Carlson made a motion to approve the easement. Roberts seconded. Roll call was unanimous. Motion carried.

Hamar discussed with the Commission the rumor that the county was taking over 87th Avenue, north of ND 11. Hamar stated that the township has no plan on turning the road over to the county. Walsh stated that his understanding was that the township was interested and apologized for that misunderstanding. Ellendale Township has worked with Tykwinski on estimates for paving of that road. Hamar also stated rumors have started that the township received over \$300,000 in fees from Applied Digital, which is correct. The reasoning for the fees was the continuation of overweight trucks when load limits were still in place this spring. Applied Digital needed to pay the fees for continuing to bring in overweight trucks. It was a significant amount of money, but a lot of trucks were hauling during that time frame. Ellendale Township is using those funds by graveling all their primary roads and placed the balance in a special road fund for future use. Discussion continued concerning the possible installation of turn lanes off ND 11 and if turn lanes can be installed entering on to a township road. The concern is the traffic issues on ND 11, turning on to or off 87th Avenue. Discussion included the probability of paving 87th Avenue and the turn lanes on ND 11 will most likely not be completed until 2025 at the earliest.

Phillips stated their concern is the state of 87th Avenue next spring but realizes the paving would most likely not happen before then. Commission encouraged Applied Digital and Ellendale Township to work together on the possible paving of that road. Commission asked Tykwinski to check into the possibility of installing turn lanes on ND 11 and leaving 87th Avenue as a township road.

Tykwinski gave the Commission the most current report as to the status of prairie dog funding that could be received in first quarter of 2025. Additional funding possibilities was also discussed. Tykwinski will work on getting applications completed for upcoming deadlines.
