Commissioner Meeting September 2, 2025

Chair Brandon Carlson called the meeting to order at 9:00 am. Commissioners John Hokana, Jerry Walsh, Kacey Holm, and Marke Roberts were also present. Auditor Sheppard was also present. The media was not present. The Pledge of Allegiance was recited. Resident Matt Herman and JETx representative Kris Koch were also in attendance.

Holm made a motion to approve the minutes- with corrections. Walsh seconded. Motion carried.

Sheppard presented two invoices for road projects payments to Bituminous Paving Inc. and Knife River Materials in the amount of \$358,257.41 and \$850,727.86 respectively. Hokana made a motion to approve vouchers as submitted, with the addition of the two vouchers. Holm seconded. Roll call was unanimous. Motion carried.

Commission discussed the tents that Chad Durheim had offered to the county for sale. No action was taken. Sheppard will inform Durheim of the decision not to purchase the tents.

Commission discussed the letter received from WAPA concerning the easements for the poles along County Road 3, west of Oakes. As stated in an earlier meeting, the easement will expire on October 1st. WAPA has stated the project will be completed by October 1st and will pay any fines for not completing the project on time. Sheppard stated a bill will be sent for any fines.

Sheppard presented a check received from Tyler Technologies in the amount of \$1,397.26 for an overpayment that was paid using ARPA money received earlier. Based on the stipulation of the federal government that the money be spent by the close of fiscal year 2024, Sheppard is requesting the money be used right away. Discussion followed concerning the use of the money. Walsh made a motion to return the check and request Tyler Technologies use the overpayment as credit on our account. Holm seconded. Roll call was unanimous. Motion carried.

Sheppard presented an agreement with ND Surplus Property that needs to be signed. Roberts made a motion to sign the agreement. Holm seconded. Motion carried.

Commission discussed the advertising of the equipment operator for the road department and the cost of the advertising on the radio. Discussion included running advertising for the sheriff deputy position as well. Walsh made a motion to run the equipment operator ad on the radio for a week. Hokana seconded. Roll call was unanimous. Motion carried.

Carlson updated the Commission on possible locations for a new Highway shop building in Oakes. Carlson has a few possibilities. No decision was made.

Herman discussed with the Commission his concern about public transportation in the county. Herman has requested assistance and has been told there was nothing available at the time requested. Herman stated that this answer came after he had answered several questions unrelated to his location. Herman stated that his understanding was that all senior meals are delivered by Oakes, including those meals in Ellendale. Commission requested that Sheppard send an e-mail to the director and ask that they attend a Commission meeting to discuss the issue.

Carlson stated that the drain on County Road 3 is being worked on. The drain cleaned and flushed well. The name of the drain was discussed and the need to change the name. The State Water Board will give the drain a new number and a better name can be given.

The meeting went into recess from 10:00 through 10:10.

The Commission discussed the Medical Services Director agreement that Health District Administrator Roxanne Holm had sent to the Commission for their review. States Attorney Radermacher has also reviewed the contract. Roxanne Holm joined the meeting at 10:15 to discuss the contract, which includes an increase in the fees. Sanford has requested the County to sign the agreement. Discussion followed concerning other options that would not involve signing an agreement with Sanford. Walsh thinks that the County should sign the agreement for right now and look at other options. Walsh made a motion to accept the agreement with Sanford at the new cost. Holm seconded. Radermacher, who was in attendance via electronic means, stated that there is a 60-day notice to cancel the contract. Roll call was Walsh yes; Roberts no; Carlson yes; Holm yes; Hokana yes. Motion carried.

Ellendale Township Supervisor Joel Hamar, Legislators Jim Grueneich and Mike Brandenburger, and Mayor Don Flaherty joined the meeting at 10:10. Sheriff Chris Estes joined at 10:15 and DES/911 Coordinator Charlie Russell joined at 10:20. KLJ Engineer Bryan Tykwinski and Highway Superintendent Jeff Hagen joined at 10:25. Applied Digital representative Martin Vega joined at 10:30.

The county taking over 87th Avenue 1.50 miles north of Highway 11 in Ellendale Township was discussed. Carlson stated that for the safety of the public, something needs to be done at that intersection. Walsh made a motion to take over control of 87th Avenue north of Highway 11 for 1.5

miles. Hokana seconded. Hamar asked if anyone had talked to ND DOT about the project and the possibility of a safety study for that intersection. Hamar also stated that the county has not done any maintenance on the road in Elden Township since the county has taken over that road. Vega stated that Applied Digital feels that the county has more resources than the township to handle the road. ND DOT funding is based on the county taking over the road.

Applied Digital representative Janelle Combs and EDF Renewables representative Sara Thorndson joined the meeting at 10:45.

Discussion followed concerning why the city did not take over the whole road at the time of annexation. Mayor Flaherty stated that the city of Ellendale worked with the map provided. Walsh called for a vote on the motion. Roll call was Holm no; Carlson yes; Roberts no; Walsh yes; Hokana yes. Motion carried.

TMobile representative Matt Foucault joined the meeting via electronic means to discuss the possible transfer of county cell phones to TMobile. Foucault stated that TMobile will bring a device to the county so that testing can be completed to verify the coverage in Dickey County. No action was taken at this time.

Resident Eric Larsen joined the meeting at 10:55 to discuss a tile application where they will need to have tile bored under County Road 8A in three spots. The line will be approximately 8 feet below the road. Larsen assured the Commission that the right-of-way will be returned to the current state. Roberts made a motion to approve the application. Holm seconded. Roll call was unanimous. Motion carried.

Tykwinski discussed with the Commission possible road projects for the flex funding applications that are due soon. Roads included County Road #2 as a micro-surface project that would extend into LaMoure County and County Road #8 south of the Oakes Road to Highway 11.

Hokana made a motion to adjourn at 11:45.

Special Commission Meeting September 3, 2025

Ellendale School Board Chair Michelle Thorpe called the meeting to order at 7:00 pm. Commissioners Kacey Holm, Jerry Walsh, Brandon Carlson, Marke Roberts, and John Hokana were present. Ellendale Public School Board members Kristi Gilbert, Cresta Miller, Michele Thorpe, Jeff Goehring, and Valerie Wagner were present. Ellendale City Council members Tom Denison, Bruce Crabtree, Tammy Belgarde, Justin Meidinger, Jon Langeliers, and Mayor Don Flaherty were present. A list of those in attendance from the public is on file at the Auditor's office.

The purpose of the meeting is to discuss the proposed new TIF district in the city of Ellendale and the effect of this district on funding for the Ellendale Public School.

Presentations were made by Moore Engineering and North Dakota Department of Public Instruction concerning the tax incentive funding (TIF) district process. Mayor Flaherty presented information compiled concerning the school funding and the effect on the school, city, and the county.

No action was taken.

The meeting adjourned at 8:30 pm.

Roberts made a motion to approve the minutes for the September 2nd and September 3rd meetings as amended. Hokana seconded. Motion carried

Walsh made a motion to approve the vouchers as presented, with the addition of invoices from Montana Dakota Utility and Dakota Valley Electric. Roberts seconded. Roll call was unanimous. Motion carried.

Hokana made a motion to sign the August 2025 financial statement. Walsh seconded. Roll call was unanimous. Motion carried.

Sheppard presented a Memorandum of Understanding received from the ND Secretary of State's office concerning the use and maintenance of election equipment supplied by the State of North Dakota. Sheppard stated that the new memorandum is required because the number of machines supplied by the state of North Dakota has changed, because of the decrease in polling locations on election day. Walsh made a motion to sign the memorandum of understanding. Roberts seconded. Roll call was unanimous. Motion carried.

City of Ellendale Mayor Don Flaherty joined the meeting at 9:25 to discuss notification the city has received from Ellendale Public School concerning the TIF district in Ellendale Acres. The school has notified the city of their intent to start formal negotiations with the county and the city concerning flexibility in opting out of the TIF district in the future. Their concern is the effect of the TIF district if/when changes in legislation occur. The Ellendale City Council has a special meeting on Monday September 22nd where they will set a date for a special meeting to start the negotiations at that time. Roberts made a motion to authorize Sheppard to send a letter to the city of Ellendale stating the county agrees to enter formal negotiations with the city and the Ellendale School District. Walsh seconded. Roll call was unanimous. Motion carried.

Roberts updated the Commission on a discussion he had with Jean Schmaltz concerning the Senior Citizen Center in Ellendale. Schmaltz wanted the Commission to know that meals are being provided at the person's residence and not at the center. The reason for the change is that without a cook, there is no one to clean up afterwards. Schmaltz stated there was no plan to take away services to Ellendale, but their only option at this time is to deliver meals from Oakes until a new cook is hired.

Pheasant Lake residents Mike Visto and Keith Lowen joined the meeting at 9:41.

Carlson updated the Commission on the work on the power lines on County Road 3 west of Oakes. The power lines are off the poles and appeared poles on the south side will get pulled. Sheppard will send a reminder WAPA to inform the county before placing stop lights on the county road.

Visto requested permission to mow 100 feet from the road at Pheasant Lake before snow comes. Visto would also like to mow where the snow is piled each winter. Walsh made a motion to hire Visto to mow back 100 feet off the road on county property and other areas that need to be mowed for placement of snow during the winter for \$1.00 and other considerations. Roberts seconded. Roll call was unanimous. Motion carried.

Sheppard presented a letter to be sent in support of the project that Divide Township is seeking flex funding from the state of North Dakota. As done in a different project, the county becomes the pass through for the project. Roberts made a motion to sign the letter of support to Divide Township for this road project. Hokana seconded. Motion carried.

The meeting went into recess at 10:05 and returned at 10:15.

Sheppard reviewed with the Commission the budget report that was placed in the newspaper before the 2026 budget hearing this afternoon. Possible changes were also discussed, which included an increase in interest income for 2025 and some reduction in expenses for 2025 and 2026. The possibility of removing the new ditch mower from the expenses for 2026 for the highway departments was also discussed.

Water Board Chairman Steve Hansen, Sheriff Chris Estes, and DES/911 Coordinator Charlie Russell joined the meeting at 10:40.

Estes and Carlson presented the lifetime achievement award to Charlie Russell from the North Dakota Emergency Management Association. This award is by nomination from their peers. A short break was taken to celebrate the award.

Highway Superintendent Jeff Hagen, KLJ Engineer Bryan Tykwinski, and Water Board member John Quandt joined the meeting at 10:55.

Quandt reported on the drain on County Road #12 that has been completed. The drain is accomplishing the desired effect, seeing a six inch drop in the water already. Discussion followed concerning the payment for the project. The Water Board and the County Commission both agree to pay half the cost of the project.

Hansen reported on the proposed OEM for the county drain #3 west of Oakes. The drain has been cleaned out and is flowing. An application will be filed by the Water Board for a drain permit to the state of North Dakota. The OEM has been forwarded to the Auditor, States Attorney, and the Commissioners for their review. Contingent on the approval of the OEM by the States Attorney, Roberts made a motion to agree to the OEM between the county and the Water Board. Walsh seconded. Roll call was unanimous. Motion carried.

Tykwinski presented a cooperative agreement with LaMoure County to apply for flex funding for funding for a road project on County Road 2 in Dickey County with continuing with County Road 64 in LaMoure County. Walsh made a motion to sign the cooperative agreement with LaMoure County. Roberts seconded. Roll call was unanimous. Motion carried.

Tykwinski presented a revised letter of agreement with Divide Township for the flex funding application for their road project. Tykwinski updated the construction year to be 2027. Roberts made a

motion to change the original letter to include the new construction date and to include another possible option for the project. Roberts made a motion to sign the letter. Hokana seconded. Roll call was unanimous. Motion carried.

Commission discussed the application received for an equipment operator for the Highway Department. Hagen stated he has received a few calls, but no other applications have been received at this time. Hagen will call to set up an interview.

The Commission went into recess for lunch at 12:15 and returned at 1:30.

Hokana made a motion to open the budget hearing. Roberts seconded. Motion carried.

There were no residents that attended the budget hearing.

The budget hearing was closed and the meeting adjourned at 1:40.
