

**Commissioner Meeting  
February 6, 2018**

Chairman Hamar called the meeting to order at 9:50 am. Present were Thor Sand, John Hokana, Marke Roberts, Dean Simek, and Chairman Joel Hamar. Stacy Bowerman, Director of South Central Dakota Regional Council was also present. The media was not present. The Pledge of Allegiance was recited.

States Attorney Gary Neuharth and Attorney Jeff Glynn joined the meeting at 9:55. With the retirement of Neuharth as of August 31<sup>st</sup>, Neuharth is requesting the county appoint Glynn as Assistant States Attorney as of March 1, 2018. Glynn has been assisting Neuharth, and learning the workings of the trial court system. Neuharth is requesting payment to Glynn for time spent March through August. Glynn would need to submit his petition to be put on the ballot for the election. Roberts made a motion to pay as requested. Sand seconded. After further discussion, Roberts withdrew the motion until Auditor Sheppard can check on the General Fund budget for 2018.

Treasurer Gail Veland joined the meeting at 10:00.

Sand made a motion to approve the minutes with changes. Roberts seconded. Motion carried.

Sand made a motion to approve the vouchers including the prisoner bill not paid last meeting. Hokana seconded. Motion carried.

Tax Director Don Flaherty and Deputy Tax Director Denise Olson joined the meeting at 10:15 to discuss 2018 assessments. County wide sales ratio for residential property is at 94.2% and commercial property is at 90.4%. The residential sales ratios show that there will need to be a market value adjustment on non-exempt rural residential land with less than 25 acres.

After a discussion on ag land, Sand made a motion to set our ag land values at 93% of the state values for ag land, in comparison to 94.3% last year. Simek seconded. Motion carried. For residential land, Roberts made a motion to set values at a 94% level with location adjustments as needed, compared to a 93.3% last year. Sand seconded. Motion carried. For Commercial property, Sand motioned to set values at 92% with location adjustments primarily in the Ellendale area, compared to 97.4% last year. Simek seconded. Motion carried. The county Equalization meeting will be June 7<sup>th</sup>. Flaherty introduced Denise Olson, as his new deputy.

Hokana made a motion to appoint Dr. Rup Nagala as the county Health Officer for a 5-year term. Simek seconded. Motion carried.

Director Bowerman discussed the process they are assisting the county in getting funding for the basement project. Bowerman also felt that the county could receive loan assistance through the Bank of North Dakota for the purchase of the new truck with snow plow attachments. The rate on the USDA loan on the basement of 3.5% is good through March 31<sup>st</sup>. Bowerman distributed the last newsletter which discussed their Child Care Aware program.

DEM/911 Coordinator Charlie Russell and Highway Superintendent Jeff Hagen joined the meeting at 11:00.

Based on recommendation from IT Consultant Jamie Nelson, Auditor Sheppard discussed with the Commissioners the need to increase the bandwidth in the courthouse. The slow speed is causing a disruption of work flow as staff is having to wait. The use of web sites to complete tasks is increasing and the current bandwidth is not enough. For \$250 more per month, our upload and download speeds can be increased from 10 megabytes to 50 megabytes. Sand made a motion to increase the internet speed to 50 megabytes. Roberts seconded. Motion carried.

Auditor Sheppard presented an agreement with AvidHawk to update the county website for \$250 to meet the standards set by the federal government, upon the request of IT Consultant Jamie Nelson. Sand made a motion to approve the agreement. Simek seconded. Motion carried.

Treasurer Veland discussed the cost of doing remote deposits with the bank. She is requesting the purchase of a remote scanner in the amount of \$610.00. First State Bank of Oakes is waiving the \$25.00 per month fee. Roberts made a motion to purchase the remote scanner. Simek seconded. Motion carried. Veland will check on how long they will waive the fees.

Veland is requesting to change account XXXXX31 held at First State Bank of Oakes from a money market account to a transitional account. We will retain the following signers of Gail Veland, County Treasurer, Cheryl Brokaw, Deputy Treasurer, Wanda Sheppard, County Auditor, and Stormy Bertsch, Deputy Auditor. The internal policy of the County of Dickey is to require two signatures, one from each office, which will be governed by the County not the bank. Hokana made the motion to change the account to a transitional account. Sand seconded. Motion carried.

The discussion concerning SIRN will be added to the agenda for the meeting of February 20, 2018.

4-H Agent Aimee Ellinger joined the meeting at 11:35. Ellinger informed the Commissioners that the performance evaluation for Ellinger and Count Agent Breana Kiser is next Tuesday, February 13<sup>th</sup> at 9:00 in case any of the Commissioners wanted to attend. Ellinger stated there will be a fund raiser for the shooting club starting at 5:00 Saturday at the Legion.

Highway Superintendent Hagen presented a map from SE Water Users showing where they are requesting to put up a new building in Section 16-132-61 in Wright Township, in which they are requesting a variance on. There are already established trees here so it shouldn't cause a snow problem. Sand made a motion to grant the variance because of the existing trees already on the site. Hokana seconded. Motion carried.

Hagen is requesting the load restrictions on county road 2 be increased to 7 ton on the section of the road between highway 11 and county road 3 when load restrictions are put in place. Simek made a motion to increase the load limit on County Road 2. Sand seconded. After some discussion, Simek changed his motion to extend the change to the county line. Sand seconded. Motion carried.

Hagen stated the gravel hauling bid hearing is set for February 20<sup>th</sup>. Hagen would like to put the county in half, instead of four sections that have been done in the past. A standardization of bids needs to be put in place so that they are more easily compared at the time of the bid hearing.

Hamar noted an article in the ND Water magazine that showed a picture of Norm Haak as he was inducted into the ND Water Users Hall of Fame. A congratulatory letter will be sent by Auditor Sheppard to Norman Haak.

Hokana made a motion to appoint Rocky Reule to the Park Board, Don K Zimbleman to the Water Board, and Jade Ulmer to the Weed Board. Simek seconded. Motion carried.

Sand will forward the LoadPass information he had received concerning changes they are making. These changes that are coming may make the system a better option for Dickey County.

Hokana made a motion to adjourn at 12:20.

## **Commissioner Meeting February 20, 2018**

Chairman Hamar called the meeting to order at 9:10. Present were Thor Sand, Marke Roberts, Dean Simek, and Chairman Joel Hamar. John Hokana was unable to attend. The media was not present. The Pledge of Allegiance was recited.

Sand made a motion to approve the minutes with changes, after consulting Tax Equalization Director Don Flaherty. Simek seconded. Motion carried

Treasurer Gail Veland joined the meeting at 9:30.

Sand made a motion to approve the vouchers, including overpaid tax refunds in the amount of \$1,585.59. Simek seconded. Motion carried.

Simek made a motion to approve the Financials. Roberts seconded. Motion carried.

Roberts reported on the Barnes County Jail meeting he attended earlier in February. The county may be better served having our States Attorney get an Attorney General's opinion on crossing state lines and housing prisoners in South Dakota. Roberts plans to continue attending the meetings to keep updated on the situation.

Hamar had attended the yearly reviews for the County Agent Breana Kiser and 4-H Agent Aimee Ellinger. NDSU District Director Ron Weiderholt stated that activities are increasing and he is happy with the activities in the county. As communicated earlier, there will be an adjustment in how the two positions are funded starting in 2019.

Chairman Hamar read the formal complaint received from Greg Richter concerning a constructed in the South ditch in the NE1/4 of section 29-132-63. The complaint is on record with the Auditor's office. This is in reference to the complaint filed with the Dickey County Water Board.

Risk Manager Cresta Miller joined the meeting at 10:00. Miller reported there will be a change in testing for new employees requiring a CDL for their job. New employees needing a CDL will need to sign a waiver allowing the county to verify their history with the Department of Transportation. At this time, nothing different will need to be done.

States Attorney Gary Neuharth, Attorney Jeff Glynn, DES/911 Coordinator Charlie Russell and SE Coordinated Regional Interoperability Board (CRIB) member Curt Halmrast joined the meeting at 10:20.

Russell informed the Commissioners that there had been no communication with Charles Carvell, Attorney with Pearce Durick PLLC, concerning the FEMA payback. Neuharth stated his office will look further into the situation to keep the process on the appeal moving forward so the situation can be resolved.

Halmrast reviewed with the Commissioners House Bill 1178 and the need for State Interoperable Radio Network (SIRN). Halmrast is requesting the Commission agree to sign a Memorandum of Understanding, relinquishing legal rights to any radio frequency required for the statewide interoperable radio network trunk system. The Commissioner can choose to reassign a callsign or enable concurrent operation of the license/frequency. It will allow a planned use of a frequency by different locations throughout the state without having interference due to proximity of agencies using the frequency. Roberts made a motion to sign a concurrent memorandum of understanding with the State of North Dakota. Sand seconded. Sheppard will forward the minutes showing concurrency once minutes are approved. Motion carried. The Commissioners requested Halmrast keep them updated.

Brad Ratzlaff, representing Ratzlaff Trucking and Highway Superintendent Jeff Hagen joined the meeting at 11:15.

Simek made a motion to open the gravel bid hearing at 11:15. Sand seconded. Motion carried.

The commission advertised for bids on each of the 2 gravel districts in the county, with District 1 beginning at the west side of the county. Three bids were received and reviewed

Sand motioned to award the gravel bids to the lowest bidder for all districts to Ratzlaff Trucking. Simek seconded. Motion carried. All bids are on file at the Auditor's Office for public viewing.

Sand made a motion to close the gravel hauling bid hearing. Roberts seconded. Motion carried. Meeting went into recess at 11:40 and reconvened at 11:45.

Hagen stated that KLI Engineer Josh Loegering is working on an estimate to fix the two bridges that may need to be fixed this year. ND Department of Transportation sent a letter stating the safety inspections for concrete box culverts can be extended to 48 months, instead of 24. Hagen felt there was no reason to not extend the cycle. Simek made a motion to have the chairman and the auditor sign the letter, extending the inspection cycle to 48 months. Roberts seconded. Motion carried.

Hagen presented an application from the City of Ellendale for placement of the storage container that the Highway shop uses. This would cost the county approximately \$250 a year. The container has been there for some time and Hagen would like to leave it where it is. Commissioner Sand will attend the next council meeting to request a government exemption on the fee.

Russell had reviewed options to add smart locks to the doors at Social Services and also at the Courthouse. Roberts stated that the city of Oakes had gotten locks through Dickey Rural Networks. Commission felt the locks need to meet fire code. Russell will come next meeting with some ideas along with costs.

Russell stated that he had spoken with IT Consultant Jamie Nelson and Roxanne Holm with the Health District concerning the county website. The Health District may want to look at developing their own website. Nelson is working with our provider, Avid Hawk on updating the website and is talking with all departments concerning needs of the web site.

Auditor Sheppard presented a Stutsman County Correctional Center contract for housing prisoners at \$65 per day per inmate. Roberts made a motion to sign the contract. Simek seconded. Motion carried

Auditor Sheppard presented an application for a temporary liquor license for a wedding dance at the Guelph School on September 29, 2018, from 5 pm to 1 am. The application has been approved by Hudson Township, but the Angry Beaver will need to show that there will be security. Simek made a motion to approve the application, once the security was approved by Sheriff Estes and the \$25 fee was received. Sand seconded. Motion carried.

Clerk of Court Andi Schimke joined the meeting at 12:45 concerning to discuss the letter received from the State of North Dakota on funding of her office for the next biennium. Schimke felt the Commission should agree to receive reimbursement for clerk services. Sand made a motion to choose the option to receive funds for reimbursement of clerk services. Roberts seconded. Motion carried.

Auditor Sheppard presented a software license agreement with VanGuard. Simek made a motion to sign the agreement. Sand seconded. Motion carried

No decision was made on the purchase of the new lawn mower for the Park Board. Commission felt that they should not override the motion made at the Park Board meeting.

Sand made a motion to adjourn at 1:10.
