The Dickey County Water Resource District met at the Court House in Ellendale, ND at 8:00 a.m. on Wednesday, November 17, 2021. Managers Steve Hansen, Keith Hauck, and Don Zimbleman were all present at the Court House. Managers Norm Haak and Justin Gemar, along with Sean Fredricks, the board's attorney and Josh Hassell, representative of Moore Engineering joined via video conference.
