The Dickey County Water Resource District met at the Dickey County Courthouse in Ellendale ND at 8:00 am on Wednesday, November 20, 2024. Ed Melroe Complaint

Sean Fredricks, the board's attorney, gave an update on the Ed Melroe complaint. Mr. Fredricks sent Mr. Melroe a letter dismissing his complaint. Mr. Melroe then had a period of time to appeal that decision, which he did not do. Mr. Melroe then sent Mr. Fredricks a letter asking for more clarity. Mr. Fredricks asked the board if they would like him to reply or dismiss the letter. After much discussion, the board felt it had no obligation to address the letter as the appeal window has been closed and further opted to not reply to Mr. Melroe's letter to Mr. Fredricks.

David Finley Tile App

David Finley applied for an "under 80" tile project. As the board has no obligation to approve any tile projects that are under 80 acres in size, no action was taken.

Dickey County Drain #1 discussion

Manager Gemar gave the board an update of Dickey County Drain #1. There is still a beaver dam issue at the outlet which Mr. Gemar is managing. Dakota Improvement has been helping to remove those dams at the advisement of Mr. Gemar. Mr. Gemar also informed the board that the pump station on Dickey County Drain #1, that was approved this past summer, has been completed by Dakota Improvement and was satisfied with the site. The cattails and other debris that holds back water was also successfully taken care of by the helicopter company the board hired.
