Commission Minutes October 4, 2016

Chairman Sand called the meeting to order at 9:05 am. Present were Joel Hamar, John Hokana, JT Homan, Dean Simek and Chairman Sand. The press was not represented.

Additions to the Agenda

Mertz Lumber

Tax Director Flaherty

Hamar motioned to approve the minutes. Hokana seconded. Motion carried.

Hokana motioned to approve the vouchers. Hamar seconded. Motion carried.

The commission reviewed the properties that are taken by the county for unpaid 2013 taxes. The beginning bid for parcel #0861000 was set at \$3,515.59, which includes the recording fee. The minimum bid amount for parcel #10724001 wasn't set until more information can be found.

Gary Mertz from Mertz Lumber joined the meeting at 10:00 Also present were Health Director Roxanne and Program Project Manager Addi Thompson. Holm presented a bid from Mertz Lumber for additional work and additional materials provided. Mertz explained the extra electrical charges include an extra wire in the event the Health District needs more load in the future. Mertz stated there was work that needed to be done that wasn't on the original bid. The construction work is complete except that a door for the conference room is on order.

Hamar motioned to pay the amount of the vouchers that were presented by Holm. Roll Call vote passed with Joel Hamar yes; John Hokana yes; JT Homan yes; Simek yes; and Chairman Sand, yes.

Hamar motioned to open the 2017 budget hearing. JT seconded. Motion carried. Present were Deputy Auditor Wanda Sheppard, 911/DES Director Charles Russel, Sheriff Chris Estes, Treasurer Gail Veland and guest Robert Schaeffer. Mr. Schaeffer asked why the Sheriff's budget was so high with fewer residents in Dickey County than in the past. The commission explained the Truck Regulatory expenses are within the Sheriff's budget and a salary for an additional deputy. Sheriff Estes stated the highway patrol doesn't assist as much as they have in the past. Estes said there is increased traffic from other parts of the state and a large portion of the costs are spent on offenders that are not Dickey County residents. After further discussion, JT Homan motioned to accept the 2017 Budget as presented. Simek seconded. Motion carried. JT Homan motioned to close the budget hearing. Hokana seconded. Motion carried. The commission thanked Mr. Schaffer for attending the budget hearing.

Highway Superintendent Jeff Hagen and 911/DES Director Charlie Russell joined the meeting at 10:49. Russell reported on the recent storm in Ellendale, stating rainfall varied from $\frac{1}{2}$ " and 1 $\frac{1}{2}$ inches. He reminded the commissioners to attend the Point Of Distribution exercise on October 7. The exercise is coordinated by Russell and the County Health District. Flu vaccines will be available and administered to the public during the exercise.

Hamar motioned to open the Propane Bid Hearing. Simek seconded. Bids were received from Economy Propane, Ellendale Farmers Union and Vining Oil. Commissioner Hamar motioned to accept the lowest propane bid, which was from Ellendale Farmers Union, in the amount of \$0.78 cents per gallon. Simek seconded. Motion carried. All bids are on file at the Auditor's Office.

Highway Superintendent Hagen told the commission the advertising for the Road Maintainer Bid Hearing advertisement has been placed in the Times Leader section of the Dickey County Leader The bid hearing is scheduled at 11:00 am during the October 18 Commission Meeting.

The commission and Hagen decided that Hagen will contact the land owners regarding hay bales that have not been removed from the county right of way.

Sheriff Estes said the truck regulatory vehicle will be patrolling during harvest. He said the Highway Patrol is not available for patrolling because of the activity in the west.

Kadrmas Lee and Jackson engineer Josh Loegering joined the meeting at 11:27. He reported the widening project is complete and presented pay estimate #5 for KD Hoyt in the amount of \$162,218.52 and Estimate #1 for Central Specialties Inc. in the amount of \$503,615.10.

Simek motioned to accept Pay Estimate #5 in the amount of \$162,218.52 and issue a check to KD Hoyt. Hokana seconded. Roll call vote passed with Joel Hamar, yes; John Hokana, yes; JT Homan, yes; Dean Simek, yes; and Chairman Sand, yes. Motion carried.

Simek motioned to accept Pay Estimate #1 for the Mine and Blend project in the amount \$503,615.10 and issue a check to Central Specialties, Inc. Hamar seconded. Roll Call Vote passed with Joel Hamar, yes; John Hokana, yes; JT Homan, yes; Dean Simek, yes; and Chairman Sand, yes.

Loegering explained that HB 1102 money will be spent towards the Widening Project and SB 2103 money will be spent on the Mine and Blend project.

Tax Director Don Flaherty joined the meeting at 11:55. Flaherty presented the paperwork from the state showing the adjusted assessment decision for the Harris Machine Building. Flaherty said the state assessed the property at \$935,000.

Flaherty presented the Vangard contract for the Chairman to sign. Hamar motioned to have the chairman sign the contract with Vangard to assess the complex properties from Vangard. Simek seconded. Motion carried. Hamar motioned to adjourn at 12:16. Hokana seconded. Motion carried.

October 18, 2016

County Commission Meeting

Chairman Sand called the meeting to order at 9:30 am. Present for the meeting were Joel Hamar, John Hokana, JT Homan, Dean Simek and Chairman Sand. The press was not represented.

Additions to the Agenda

Request for 4-way stop sign

Review County Benefits.

Hamar motioned to approve the October 2 Commission Minutes. Simek seconded. Motion carried.

Simek motioned to pay the vouchers. Hokana seconded. Motion carried.

Homan motioned to accept the financials as presented. Simek seconded. Motion carried.

The commission reviewed the benefits that Dickey County offers to employees. They proposed an increase in annual paid sick leave from 10 days to 12 days and proposed the following increase in vacation days.

12 days – 0 to 4 years of employment

15 days 5 to 7 years of employment 17 days – 8 to 19 years of employment 20 days – 20 and over years of employment

The maximum vacation carry over from one year to the next for non-Social Service employees remains at 15 days.

The proposal will be emailed to County Office Department Heads for their input.

Tax Director Don Flaherty joined the meeting at 10:30. Simek motioned to open the abatement hearing. Hamar seconded. Motion carried. Tax Director Flaherty presented the abatement request for Bethlehem Lutheran Church in Forbes. He explained abatement of taxes is requested because the building isn't being used and will be moved off the property. Simek motioned to accept the abatement request. Hamar seconded. Motion carried. Hamar motioned to close the abatement hearing. Homan seconded. Motion carried.

Treasurer Veland presented the Quarterly Report and Pledge Report. Homan motioned to accept the Quarterly report and Pledge Report and have the Chairman sign the report. Hokana seconded. Motion carried.

Jeree Meyers, representing RDO Equipment Co., joined the meeting at 11:00. Hokana motioned to open the Road Grader Bid Hearing at 11:00 am. Hamar seconded. Motion carried. Present for the bid hearing were Jeree Meyers, Highway Superintendent Jeff Hagen, 911/DES Director Charlie Russell, Kadrmas, Lee and Jackson (KLI) Engineer Josh Loegering, and Treasurer Gail Veland. One bid was received from RDO Equipment Co., Aberdeen SD.

The following bid was opened and read by Chairman Sand.
One 2017 John Deere 772 GP Road Grader \$297,000

(with guaranteed buyback)

Options: \$8,500 - Ripper

\$19,200 - Walk'n' Roll Packer/Roller

\$ 2,152 – Laminated Glass

Meyers said RDO Equipment Co. will repurchase the county's currently leased John Deere Road Grader (s/n 638182) for \$150,000 and the leased John Deere Road Grader (s/n 643209) at the guaranteed buyback amount of \$156,850.

Simek motioned to accept the bid for one 2017 John Deere GP Road Grader with a Ripper and Walk'n Roll Packer/Roller for the bid amount of \$324,750 and one 2017 John Deere GP Road Grader with a Walk'n Roll Packer/Roller for the amount of \$316,250. Hokana seconded. Roll call vote passed with Joel Hamar, yes; John Hokana, yes; JT Homan, yes; Dean Simek, yes; and Chairman Sand, yes. Motion carried. The commissioners may look into options to sell the two road graders outright instead of trading them in.

KLJ Engineer Josh Loegering presented a payment request in the amount of \$1,548,691.15 to be paid to Central Specialties, Inc. (CSI) for the County 3 Mine and Blend project (CNOC 1112-070) and a Reimbursement Request in the amount of \$1,548,691 to be paid to Dickey County from SB 2103. Simek motioned for the chairman to sign the payment request for CSI in the amount of \$1,548,691.15 and the auditor to sign the reimbursement request from SB 2103 in the same amount. Homan seconded. Motion carried. Loegering said the Mine and Blend project is complete and the remaining retention amount will be paid to CSI after the final inspection is completed.

Loegering presented a Payment Reimbursement Request from HB 1176 in the amount of \$6,628.62 to reimburse Dickey County for payment to KD Hoyt, Inc. Hamar motioned to have the auditor sign the reimbursement request. Hokana seconded. Motion carried.

Hamar motioned to authorize Treasurer Veland to transfer funds from First State Bank of ND, Oakes to Starion Financial, Ellendale and pay the CSI payment request from the regular checking account at Starion. Simek seconded. Motion carried.

Loegering explained that KD Hoyt, Inc. was following the correct procedure when they mailed the letter to the commission regarding the differences between actual and estimated cost of materials used on the County 3 widening project (1112-069). KLJ will respond to the letter asking KD Hoyt, Inc. for the detailed backup paperwork to their request.

The commissioners reviewed the property that came back to the county for taxes due (parcel #10724001). The minimum bid amount for the property was set at \$7,479.43, which includes the cost of a survey. Parcel #0724001 will be advertised in the Times Leader for three weeks before the November 15 tax sale, unless the legal owner or heirs pays the taxes and penalties due on the parcel before the tax sale. Homan motioned to have KLJ survey parcel #10724001 (W 60.6 feet of Lot 2 Block 43 & Block 43 Outlot X, City of Oakes). Hokana seconded. Motion carried.

Road Superintendent Hagen said he received a quote from the maintenance manager for RDO, Aberdeen SD, Inc. to repair the county mower that the county uses to mow around bridges. The quote was for approximately \$4,800 for parts and repairs. Hagen received a bill in the amount of \$7,300 to repair the mower. Jeree Meyers will visit with RDO management about the extra charges.

Commissioner Hamar told Hagen he was told by a resident that a semi-truck sped through the County 5 intersection in Kentner Township. The resident said visibility and speed make the intersection dangerous and asked if the county could place a 4 Way stop sign at the location. Discussion followed. Hagen will look into placing the 4-Way stop sign.

Hokana motioned to adjourn the meeting at 12:48 pm.
