## July 5, 2016 Commission Meeting

Chairman Sand called the meeting to order at 9:00 AM with Commissioners Joel Hamar. JT Homan, John Hokana, Dean Simek and Chairman Thor Sand present.

Sand presented a map of Pheasant Lake that pinpointed where a parcel of property that belongs to the county is located. The commission may offer the property for sale.

Simek motioned to approve the minutes. Hamar seconded. Motion carried.

Hamar motioned to approve the vouchers in the amount of \$269,230.12.

The salary review proposal in the amount of \$1,000 from Tanya Weiler was reviewed and accepted by the commissioners.

Travis Anliker, representing Dickey Rural Network, joined the meeting at 10:14 to present a proposal for a new phone system. He explained the Dickey County Social Service offices are pricing the phone systems. Mr. Anliker presented the advantages of the IP Centrex telephone system to the commissioners if and when they update their current system because the IP Centrex phones are integrated throughout the county phones, which will allow call transfers between all phone locations. In addition the new system does not have separate line and feature charges. No action was taken by the commission at this time.

Josh Loegering joined the meeting at 10:49 am. He presented the first estimate for payment from KD Hoyt for the widening project on County 3. Simek motioned to pay the voucher in the amount of \$99,302.53. Hokana seconded. Motion carried.

Loegering presented the county's copy of the contract with Central Specialties, Inc. (CSI) for the mine and blend project on County 3 (CNOC 1112(070).

Loegering gave an update on the roof project. He said the architect could have the architect's drawing of the roof design for the Historical Society in approximately three weeks. Sand asked Loegering why brackets attaching the cement beam to the courthouse wall were necessary. Loegering explained the structural engineers determined the cement beam was attached to the side of the exterior wall instead of laid on top of the wall. He said he would show the completed architect drawing to contractors and ask if the project can be completed in 2016.

911/DES Director Russell joined the meeting at 11:00 am. Chairman Sand asked Russell about changing his mobile phone number to a local number if the phone system proposal is accepted. Russell would rather keep his current phone number because it is well known in the surrounding area.

Russell reported on the hazardous weather in the Forbes City area and also the missing child incident. Sheriff Estes joined the meeting at 11:45 am and reported on the area damages caused by the storm that took place in the Forbes area on July 4.

The meeting adjourned at 12:15 pm.

## July 19, 2016 Commissioner Meeting

Vice Chairman Hamar called the meeting to order at 9:12 AM with Commissioners JT Homan, John Hokana, Dean Simek, and Vice Chairman Hamar present. Commissioner Sand was unable to attend. The press was not represented.

The Pledge of Allegiance was recited.

Simek stated that all the culverts are placed on Dickey County 3. The road is rough in some locations, and there is still dirt work to complete.

Simek stated that the fair was well attended. He felt the arena needs to be larger for some of the rodeo events.

Hokana motioned to approve the minutes. Homan seconded. Motion carried

Deputy Auditor Sheppard presented a quote to replace the current postage machine. Discussion followed. Simek motioned to lease a new postage machine. Homan seconded. Motion carried.

Simek motioned to approve the vouchers, with an addition of \$21.13 for an overpayment of taxes and the exclusion of two vouchers to Neopost for the postage machine. Homan seconded. Motion carried.

Hokana motioned to approve the financials. Simek seconded. Motion carried

Treasurer Veland joined the meeting at 9:45. Veland asked for a motion to authorize the signers for the \$30,000 CD purchased for First Community Credit Union for collateral on a

\$30,000 JDA loan to Larry Schumacker dba Geo-matoes. Simek motioned that the authorized signers on the \$30.000 Certificate of Deposit purchased for First Community Credit Union as collateral on a \$30,000 Job Development Loan to Larry Schumacker dba Geo-matoes are Treasurer Gail Veland, Deputy Treasurer Cheryl Brokaw, Auditor Beverly Beethe and Deputy Auditor Wanda Sheppard. It is county policy that two signatures, one from each office, are required on the Certificate of Deposit. Hokana seconded. Discussion followed. Motion carried.

Veland presented her Quarterly and Pledge report for the quarter ending June 30, 2016. Homan made a motion to accept the report. Hokana seconded. Motion carried.

A request has been received for board representation from the South Central Dakota Regional Council. Commissioner Homan will attend.

A request has been received for board representation from the Job Development Authority. Board decided Chairman Sand will attend until the election in November.

911/DES Director Charlie Russell joined the meeting at 10:35. Russell informed the Commissioners of elopements occurring and corrective measures that are being discussed. Discussion followed about public concern that sirens were not blown during the storm on July 4<sup>th</sup>. Protocol for handling storms that do not appear to involve tornadoes needs to be developed. Russell is working on developing protocol for the new Public Information Officer, who will be the main contact for all public information to be released to the public.

Custodian Scott Peterson joined the meeting at 10:50 concerning the irrigation system in the south side of the court house lawn. The magnetic shut offs in each zone can no longer be repaired. 6 are currently working and the 2017 budget will have funds to repair the shutoffs as they go bad.

Highway Superintendent Jeff Hagen and Jeree Meyers from RD joined the meeting at 11:05. Meyers presented information to the commissioners concerning replacement of road graders that are coming out of warranty or the lease is completed. He also submitted quotes for the purchase or lease of replacement blades. No action was taken by the commission.

Hokana asked Hagen about load restrictions on the bridge west of Fullerton on Dickey County 6. Hagen stated the ND Department of Transportation recommended the bridge be at 31 ton restrictions. Hokana said a resident told him that much weight isn't on the bridge at any one time, because of the narrowness of the bridge. Hagen stated that may be correct but if something does happen and the truck is over 31 ton, the truck owner's insurance will be at fault.

Sheriff Chris Estes joined the meeting at 11:45. Estes stated the truck regulatory vehicle is being used 4 to 12 hours a week. Estes told the commissioners that there will be an intoximeter in the Sheriff Office to abide with law changes. There will be no cost to the county and law enforcement will be trained to operate the machine.

Commissioners asked Estes about using search dogs. Estes stated dogs can be expensive and difficult to get. He said if necessary he could deputize an officer from Brown County if a dog was needed.

The meeting adjourned at 12:15 pm.
