Dickey County Commission Meeting

November 1, 2016

Chairman Sand called the meeting to order at 9:30 am. Present for the meeting were Joel Hamar, John Hokana, JT Homan, Dean Simek and Chairman Sand. The press was not represented.

The Pledge of Allegiance was recited.

Hamar motioned to approve the minutes. Homan seconded. Motion carried.

Simek motioned to approve the vouchers. Homan seconded. Motion carried.

Treasurer Gail Veland attended the meeting at 9:18. She requested authorization to send \$300 to ND Unclaimed Property because the check written to Myron Masset is not cashed. Mr. Masset can submit paperwork to ND Unclaimed Property Division to receive payment from them.

The board reviewed the State Fair letter of request to appoint a delegate to represent Dickey County. Hamar motioned to appoint 4-H Agent Breanna Kiser as a State Fair Delegate. Simek seconded. Motion carried.

Chairman Sand updated the commission regarding the October 24 JDA meeting that Sand and Simek attended. He said the JDA had a request for a grant to pay the salary for the part-time employee of the Ellendale Opera House. Sand said the employee, Justin Meidinger, gave a good presentation. Sand said the board may reconsider the grant request 2017 because the JDA 2016 budget is spent.

Health Director Roxanne Holm joined the meeting at 10:15. She distributed a copy of the On-Site Treatment System Permit Plan and Installation Approval. Holm said the permit plan was accepted by District Health Director Marci Beta. She further stated home owners who have new septic systems installed have to get an easement from adjoining landowners if the system is to be installed on less than 1 acre. Simek motioned to have the Chairman sign the easement for Earl Gall, pending approval by the States Attorney. Hokana seconded. Motion carried with 4 Yes votes and one No vote.

Sheriff Chris Estes attended the meeting at 10:40. He said two Dickey County Sheriff's deputies assisted Morton County with the pipeline protest last week. The deputies are back in the county and paperwork is submitted to ND State for reimbursement to the county for wages and expenses.

Estes asked if he could hire someone clean their office a couple times a month. Currently the sheriff and his staff are cleaning the office. No decision was made at this time.

Road Superintendent Jeff Hagen, RDO, Inc. representative Jeree Meyers, and KLJ Engineer Josh Loegering joined the meeting at 11:00 am. Mr. Meyers said at this time the resale value for road graders is less than the price quoted on the sales proposal. He said the county has time to decide and that he will keep checking to see if the resale value increases.

Meyers said he is looking for the best lease financing options for the 2 road graders on order.

Loegering submitted pay request # 4 to the commission for signatures. Hamar motioned for the chairman to sign Pay Request #4, as presented by Loegering, for Central Specialties, Inc. (CSI) in the amount of \$2,802.06 for the County 3 Mine and Blend project (1112-070). Simek seconded. Roll call vote passed with Joel Hamar, yes; John Hokana, yes; JT Homan, yes; Dean Simek yes; and Chairman Thor Sand, yes.

Hamar motioned to sign Pay Request #6 for K.D. Hoyt, Inc., as presented by Loegering, in the amount of \$51,725.05 for the County 3 Widening project (1112-069). Roll call vote passed with Joel Hamar, yes; John Hokana, yes; JT Homan yes; Dean Simek yes, and Chairman Thor Sand, yes.

Road superintendent Hagen said the Forbes blade man is retiring November 2. Hagen will place a help wanted ad for a blade operator and shop employee on Job Service, as well as in the Dickey County Leader and the Aberdeen News.

Aimee Ellinger, Youth Development and 4-H Director, told the commissioners that the County Agent's Office is rearranging their offices and updating the computer programs so all County Agent employees will have the same computer programs. She also told them she is certified to teach Family Consumer Science Education.

Theresa Blondo, representing Dickey County Housing Authority, submitted a resignation letter from Board Member Deb Tank. She asked the commission to appoint a replacement to represent the county. Blondo stated in the past a County Commissioner has sat on the board as well.

Blondo requested a key to the courthouse because there are times when she needs to retrieve client files before or after hours and for clients who live outside of the county. Blondo will visit with the Clerk of Court Office about the availability and the cost of a key.

Hokana motioned to adjourn at 12:05 pm. Homan seconded. Motion carried.

Commission Minutes

November 15, 2016

Chairman Sand called the meeting to order at 9:05 am. Present for the meeting was Commissioners Joel Hamar, John Hokana, JT Homan, Dean Simek and Chairman Sand. The press was not in attendance.

The Pledge of Allegiance was recited.

The Commissioners extend Congratulations to the Ellendale-Edgeley-Kulm football team on winning the 2016 State Championship.

Hamar motioned to approve the minutes. Homan seconded. Motion carried.

Simek motioned to pay the vouchers. Hamar seconded. Motion carried.

Hokana motioned to approve the financials as presented. Homan seconded. Motion carried.

Hamar motioned to approve the temporary liquor license for Seasons Bar from Harvest Inn, Inc. to serve alcohol at the Oakes Golf Club. Hokana seconded. Motion carried.

Chariman Sand said he received a request from a homeowner to post the county land that is located near the residence. The commission talked about the county property being public land and they are hesitant to post a no hunting sign. They will verify with the game warden that the property is within restricted distance from a residence before taking action on the request.

Clerk of Court Andi Schimke reported the grant for the courthouse roof is ready to be submitted and asked Chairman Sand to sign the paperwork. The amount of the grant request is \$146,287. Hamar motioned to have the chairman sign the application for the grant as submitted by Clerk of Court Schimke. Simek seconded. Motion carried.

Hamar motioned to open the County Tax Sale at 10:30 am. Homan seconded. Motion carried.

The county auditor offered one property described as Lot 13, Block 29, Ellendale City 1st Addition (parcel #0806000), for a minimum sale of \$3,515.59. No bids for the property were received. Simek motioned to close the tax sale. Hokana seconded. Motion carried. Hamar motioned to abate the taxes on the property and deed Parcel #0806000 to the City of Ellendale. Hokana seconded. Motion carried.

Casey Peterson attended the meeting at 10:40 am. Mr. Peterson explained that Kentner Township officials approved a cattle feed lot. He said the township doesn't have a zoning ordinance so the feedlot falls under the county's

zoning laws. Peterson said the facility meets health standards. Hokana motioned to authorize the chairman to sign the zoning request application from Casey Peterson and approve a feedlot in Kentner Township, Dickey County. Simek seconded. Motion carried.

John Quandt joined the meeting at 10:44 to update the commissioners on the progress of the Lovell Township drain that is located along 114th Ave. Mr. Quandt presented aerial photos of the drain and explained the amended permit includes the lateral effect on existing government wildlife easements. He said state agencies involved in the permitting process include the Department of Health, Department of Transportation and Fish and Wildlife.

Deputy Auditor Wanda Sheppard presented the Blue Cross/Blue Shield insurance information that Chairman Sand requested. She distributed paperwork showing a comparison of the coverage and cost of Sanford Insurance and Blue Cross Blue Shield Health Insurance policies. Currently the county has Sanford Insurance through ND Public Employment Services (PERS) and Avera in South Dakota does not accept Sanford Insurance. The commission requested the quote from Blue Cross Blue Shield because several employees have Avera Clinic and Hospital in Aberdeen as their healthcare provider. No action was taken at this time.

The commission revisited the county employee benefits. Hokana motioned to follow the state Social Services policy for the number of years worked before an employee's vacation days increase and the state accrual of days that can be carried forward. Motion failed for lack of a second.

Homan motioned to use the same incremental vacation schedule that Social Services follows. Hokana seconded. Motion carried.

Hamar motioned that vacation days be increased for non-Social Service employees be increased from 10 days to 12 days for the first three years of employment and incremental increases as discussed, with a maximum of 20 vacation days and 15 days that can be carried forward. The vacation time is in addition to the day off for the employee birthday. Homan seconded. Motion carried.

Hamar motioned to change from 10 days to 12 days of sick leave, with a maximum carry over at 30 days. Simek seconded. Motion carried.

The commission tabled discussion regarding new overtime legislation for nonexempt employees until the states attorney is available for advice.

Risk Manager Cresta Miller delivered the safety inspection check list for the courthouse. She explained that she is working on resolving hazards that can be resolved. Miller explained the hazards that cannot be changed are built in accessories such as spiral stair cases.

Road Superintendent Jeff Hagen and Kadrmas, Lee and Jackson Engineer Josh Loegering joined the meeting at 11:15 am. Loegering updated the commission on the December 8 meeting with KD Hoyt and presented a change order for Dickey County 3 (CNOB-OC #1112-69) in the amount of \$74,198. The change order is for the reduced amount of dirt work on the County 3 project and the preliminary work KD Hoyt did on the intersection of County 8 and County 3. Simek motioned to authorize the chairman to sign the change order as presented by Loegering. Homan seconded. Motion carried.

Homan motioned to have the auditor sign the reimbursement request in the amount of \$74,198. Simek seconded. Roll call voted carried with Joel Hamar yes; John Hokana yes; JT Homan yes; Dean Simek yes; and Chairman Sand yes. Hamar thanked Loegering for representing Dickey County during the meeting with KD Hoyt and complimented him for a job well done.

Loegering submitted progress estimate #5 for Central Business Inc. (CSI) in the amount of \$132,105.91, stating the 5% retainage on the mine and blend project (CNOC 1112-070) remains to be paid. Simek motioned to have auditor sign the reimbursement request for payment to CSI. Homan seconded. Roll call vote carried with Joel Hamer yes; John Hokana yes; JT Homan yes; Dean Simek yes; and Chairman Sand yes.

Road Superintendent Hagen reported the Ellendale City officials talked to him about building a shared salt storage building. Hagen offered to meet with the Ellendale City Council about the building. Chairman Sand authorized Hagen to look into the shared project.

Hokana motioned to pay the agreed upon amount of \$4,800 to John Deere Financial for repair to the mower at the county shop. Simek seconded. Motion carried.

The commissioners thanked JT Homan for his service as an interim commissioner until the November 8 election. Mark Roberts will begin his term as Commissioner on December 6, 2016.

The meeting adjourned at 12:15 pm.
