Commissioner Meeting May 2, 2017

Chairman Sand called the meeting to order at 9:15 am. Present were Joel Hamar, John Hokana, Marke Roberts, Dean Simek and Thor Sand. The press wasn't represented.

The Pledge of Allegiance was recited.

Commissioner Hokana motioned to approve the minutes for April 4th and April 21st meeting. Roberts seconded. Motion carried.

Commissioner Hamar motioned to approve the vouchers. Simek seconded. Motion carried

Commissioners Roberts and Hokana reported on the hearing in Sargent County concerning closing or vacating of section lines. Their understanding was that a majority of the people attending the hearing were opposed to closing or vacating the section lines. Sargent County Commissioners decided to not allow the closing for this drainage project. Roberts and Hokana were asked to attend a gathering with the Lovell & Riverdale township officials. Roberts had talked with Aaron Birst, a lawyer with ND Association of Counties, to get more clarification. Commissioners can vacate or close a section line temporarily, but they can't give it away completely because it isn't theirs to give away according to Supreme Court rulings. The law states it needs to be to the benefit of the public and that could be questionable. They may purchase the land next to the section line and have the drain on the property not on the section line. Hokana recognized Roberts for the thorough research he had done and how well he represented the commission at the meeting with the townships. Commissioners can't rule in the future so the next board of commissioners could change that. Hamar spoke with Mark Verke from ND Insurance Reserve Fund who was in the area and had seen the Lovell Drain. Verke felt that they are doing it right. Dickey County will not have a hearing since it is not something the Commissioners can legally do.

Deputy Auditor Sheppard presented a letter received from the Dickey County Water Board concerning work needing to be done at Wilson Dam. The county owns the park land there, but the dam is the responsibility of the water board. Commissioners will ask State's Attorney to send a letter and return the form to the Water Board.

Sheppard presented a proposal from Otis Elevator to change the company that completes maintenance on the elevator at the Court House. Our current vendor has not been completing their quarterly maintenance since July, 2016. Commissioners will discuss with States Attorney Neuharth to send letter to the current vendor to cancel the current contract. Once the agreement is cancelled, a contract with Otis Elevator will be reviewed.

Sheppard presented bond paperwork for the Edgeley School that needs to be signed and returned. Simek motioned to sign and return the paperwork. Hokana seconded. Motion carried.

The meeting recessed at 10:15 and reconvened at 10:25.

911/DES Director Charlie Russell joined the meeting at 10:25 am. Sharon Ulmer is coming to give the Commissioners an update on FEMA. Russell is currently working on 911, as the State is requiring physically addressing every building. The FEMA lawsuit is still exchanging paperwork and has not been resolved.

Kadrmas Lee and Jackson (KLJ) Josh Loegering joined the meeting at 10:30. Russell stated there is an issue on the Beethe drain. The drain starts at 88th Street and 97th Avenue. Roberts has heard that the drain is full of silt. It has some silt in it, but that is not the issue. The pipe in the approach that is in the middle of the drain is full of water, while pipe before and after the approach are not full. They are assuming the pipe may have sunk or there is a heave in the pipe. The plan is to shoot the pipe to see where the problem is that is causing the backup.

FEMA administrator Sharon Ulmer joined the meeting at 10:40 am. Ulmer distributed to the Commissioners an explanation of where things stand with the FEMA projects outstanding with Bismarck. They are still working on the large projects that FEMA shows are still outstanding. Ulmer is back to working full time to get the issue straightened out with FEMA.

Highway Superintendent Jeff Hagen, Jeff Radermacher & Joel Durheim joined the meeting at 11:00 am. Radermacher had received a letter from States Attorney Neuharth about the drain and the road ditch that the Commissioners had received a complaint on County Road 1. Radermacher stated Roger Hildenbrand cleaned the ditch out 3 or 4 years ago. They cleaned up a spot that was higher so that it would get cleaned out. It is in the County Road right of way and he didn't have permission from the county. Radermacher had it signed up with NRCS as a legal drain. Radermacher asked what needs to be done to correct the problem. NDCC 24-05-23 states that it needs to be returned to original state. Ditch has been used as a drain over the years and Hildenbrandt has kept it cleaned out. The water drains through the ditch and continues on to the Maple Creek. Hokana would like to converse with the State's attorney about the situation. Commissioners were not aware of the FSA documentation but the county right of way should not have been done without the approval of the county. Radermacher is

going to get the information to States Attorney Neuharth showing the drain approval from NRCS. The map from NRCS would have a yellow triangle on the map for this year showing it is an approved drain.

Joel Durheim presented a map of the State Line road concerning a drain along the north side of the road. Highlights that are red mark where it needs to be cleaned out and the yellow has already been cleaned out. It is not a major water shed, but there some spots that are 1.0 foot to 1.5 feet. The deepest cut would probably be by James Brauer's yard in section 32 which would be a 1.0 to 1.5 foot cut. When cleaning the yellow section, Carruth had found that once he got past the silt, he came to clay, which was where he stopped. What they are proposing is to clean it out to maintain and improve the integrity of the road. This would be ditch maintenance at no cost to the county. Highway Superintendent Hagen feels it will help the road and having a local contractor will make sure the integrity of the road is maintained. Hamar motioned to allow the cleaning at the expense of the landowners to restore the integrity of the ditch to its original point without increasing the drainage, with the approval of Hagen and NRCS. Roberts seconded. Motion carried. Hamar reminded Durheim that they may want to look at approaches and reminded him about the permits that need to be approved if changes are made to approaches.

Highway Superintendent Hagen presented a bid from Bargen Inc. to finish the gap on County Road 3 between the intersection at County Road 8 to Highway 281 to fill the cracks not completed in 2016 in the amount of \$39,285.

Hagen stated there are issues on County Road 3 drain. They cleaned it out on the east end to the inlet. He feels the problem may be in the open section of the drain. Their backhoe can't reach it, so they would have to farm it out. The section to clean out would be approximately 500-800 feet. There is also a problem at Enger Slough which needs rocks for rip rap but finding rocks is the problem. There was a lot of erosion when the project was started. Hagen talked to Skip Worrell and he has some rock, as well as Pat Anderson but he is a long haul. There have been some complaints on drop offs on the shoulder of the road. They will try to auger off the side of the truck and try to level off some of the shoulders. Loegering stated that some of the drop offs are more than two inches and will have to be fixed.

Hagen stated that load limits have been taken off state roads. Hagen decided to not take them off county roads because they are not ready for another week at least.

Hagen received a quote from Warren Moe from Oakes Truck and Trailer. Moe has access to a couple of the trucks that would be a replacement for truck that blew up. Discussion followed where the funds would come for to fix or replace the truck. The replacement of the truck should be replaced over finishing the gap on County Road 3. The road work to be done on County Road 2 and the amount of that project is still unknown. Hagen will let Moe know they will go ahead with the truck

Sand reported to Hagen that he had been told that people are very happy with Daryl Lematta's work and Hagen said he would let Lematta know.

Loegering presented an amendment to the contract for design engineering on County Road 2. It is a positive adjustment of \$16,700, to bring the total agreement to \$32,200 for modifications and additional services to be performed. The original agreement of \$15,500 was approved earlier. Simek made a motion to sign the Amendment to the design engineering contract on County Road 2. Hamar seconded. Roll call vote was unanimous with Hamar yes, Hokana yes, Roberts yes, Simek yes, and Sand yes. Motion carried.

Loegering requested a motion on Annual wetland mitigation monitoring on up to 5 years on a miscellaneous agreement, which is a contract to not exceed \$5,000. KLJ staff completes the information and reports it to the Corp. of Engineers. Roberts motioned to sign the agreement. Hokana seconded. Roll call vote was unanimous with Hamar yes, Hokana yes, Roberts yes, Simek yes and Sand yes. Motion carried

Loegering reported on the roof project, which now has an estimated cost of \$198,000. The cost has increased because of how the draining will be done. The pre-bid hearing for any vendors who want to walk through the project is at 10:00 am on May 9^{th} . The bid opening will be May 19^{th} at 10:00 am in the Court Room, if available. Blow in insulation is included in the price.

States Attorney Neuharth joined the meeting at 12:00. A letter was received from the State Engineer concerning Wilson Dam. Neuharth will send a letter that the dam is the responsibility of the Water Board.

The contract on the elevator maintenance was discussed. The agreement with Kone is good for 2017. Kone's contract needs to be terminated since they are not performing the requirements of the contract so that we can enter into a new agreement with Otis Elevator. Deputy Auditor Sheppard will get the information to Neuharth and he will draft a letter.

Chairman Sand reviewed the situation with Radermacher and the Richter complaint. It is permissible to clean the drain out if it is an approved drain. Lindsey Goldade is the contact at the NRCS and would be able to give information on that location. Radermacher was asked to submit the information as well. Neuharth will get ahold of Goldade.

Sheriff Chris Estes and Clerk of Court Andi Schimke joined the meeting at 12:15. Since Schimke's grant was used to fix the roof. Schimke would still like to do a security window at their counter and to update their passport system. Hamar requested additional bids for the project. The next grant period is September, being awarded in March, 2018. The Historical Society has approved the change. The Commissioners discussed with Schimke on options for

the counter. Schimke will research the difference of level 1 or 2 glass as far as what kind of bullet it will stop and will report back to the Commissioners at the next meeting.

Schimke would like to update the Passport system. The printer that is used is not working very well anymore. In order to update the printer, the whole system has to be updated, as it comes in a package. Commissioners asked that she check with Jamie Nelson from Computer Express to see if he can get the system at a different rate but to go ahead with whichever option is best. The total cost of the project is \$2,425.49.

Schimke would also like to add two cameras in the courtroom. Estes brought up that he believes the wiring has already been done. Estes would talk with Jake Rall and Travis Anliker from Dickey Rural Network, because Estes thought they waited last year until the roof was completed but was not sure what the reasoning was. Schimke and Estes are going to check into the situation and get back to the Commission.

Sheriff Estes is requesting to advertise using level 6 on the pay scale to fill his deputy position, as they are not getting interested individuals at the rate the county pays. Currently, there are 17 openings state wide. Commission will look at salaries, specifically the deputy sheriff salaries.

Simek motioned to adjourn at 1:30 pm.

Commission Meeting

May 16, 2017

Chairman Sand called the meeting to order at 9:30 am. Present were Joel Hamar, John Hokana, Marke Roberts, Dean Simek and Chairman Sand. The press wasn't represented. The Pledge of Allegiance was recited.

Additions to the Agenda

Historical Society Funds Distribution

Drain on Radermacher property

Commissioner Hamar said he contacted NRCS regarding the drain complaint the commission received from Martin and Greg Richter. He said NRCS could not release drain agreement information to Hamar or States Attorney Neuharth. The information needs to be requested from the owner of the land the drain is located on.

Commissioner Hokana motioned to approve the minutes with amendments. Simek seconded. Motion carried.

Commissioner Roberts motioned to approve the vouchers with the addition of SE Water Users in the amount of \$46.05 Hokana seconded. Motion carried.

Hamar motioned to approve the financials. Simek seconded. Motion carried.

The commission discussed courthouse security in the individual offices. The offices of the Clerk of District Court, District Judge and courtroom areas are the only spaces in the courthouse that are covered with the Courtroom Security grant.

Dale Radermacher, representing the Monango Historical Society, joined the meeting at 10:10 A.M. He said Monango City felt 2.5% of the money was adequate when the proceeds of the one-fourth mill were initially distributed to the County Historical Societies. They are now in need of a greater share of the tax collections and asked to receive the same amount as the other small cities. Following is the allotment given to each historical society in Dickey County as recorded in the November 7, 2005 Commission Minutes. Oakes 35.5%, Ellendale, Coteau Hills, Fullerton and Ludden cities receive 15.5%, while Monango City receives 2.5%. The commissioners explained the decision to make adjustments to the initial allotments is the responsibility of the Dickey County Historical Board. Commissioner Sand asked Radermacher to update the commissioners as to whether or not Monango City is satisfied with the decision of the County Historical Board.

The commission reviewed the law enforcement salaries from counties with relative equal populations to Dickey County. The shortage of law enforcement in North Dakota is affecting the ability to hire sheriff deputies for Dickey County, although it appears that Dickey County is within the range of the surrounding counties. Roberts said paying for training is a long term commitment and it isn't unheard of to offer training to someone who is interested in joining law enforcement and wishes to live in a rural area. Roberts explained that Oakes City is also searching for a law enforcement deputy and it may be in the best interest of the county and Oakes City to work together.

The commission discussed whether the salaries for road department employees and sheriff deputies should be reviewed. Hokana said the salaries of the open positions in the road and sheriff departments should be addressed at this this time and other salaries will be reviewed during budget time. Deputy Auditor Sheppard will furnish the commissioners with information and the cost to the county if salary increases are granted for the two departments.

Sheriff Estes joined the meeting at 10:40 am. He said two people have applied for the deputy position and will be interviewed on May 20. He asked if a commissioner is interested in sitting in on the interview. Discussion followed about incentives outside of pay that could bring law enforcement candidates to Dickey County. Other discussion included the monitoring bracelet contract may be extended to cover Social Services and the emblems used to identify the truck regulatory vehicle.

MDU Substation Engineer Dan Albrecht joined the meeting at 10;30 and distributed drawings of the substation being constructed for the Big Stone South to Ellendale (BSSE) project.

Construction should begin around July or August of this year and finish in 2018. The photos are on file at the auditor's office for public review.

Road Superintendent Hagen joined the meeting at 11:00. Hagen reminded the commissioners that the bid hearing for the courthouse roof project is Friday, May 19 at 10:00 AM in the county courtroom. Hagen also said KLJ Engineer Loegering informed him that five bidders have asked for plans for the County 2 project. He stated the Glynn crossing is finished although recent rains prevent work on the other crossings for a while. He said the new truck from Oakes Truck and Trailer is ready for delivery. Hagen will assure that coverage from ND Insurance Reserve Fund is in place before taking the truck off the lot. Other discussion included road blading schedules and maintenance projects. Hagen said that Alex Dathe is hired to work at the road department during the summer.

The road department has a position open for an employee with a CDL. Discussion followed about waiving the requirement for a high school diploma or GED if the applicant has a CDL. Discussion was tabled.

Commissioner Simek motioned to adjourn at 11:48.
